

ORDINANCE No. **187958**

\*Pay claim of Radio Cab for the total sum of \$6,349 involving the Portland Police Bureau.  
(Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Radio Cab has filed a property damage claim against the City for vehicle damage and downtime resulting from a collision which occurred on July 6, 2015.
2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award and attorney's fees, we feel it is prudent to compromise the claim at this time.
3. Risk Management Services and the City Attorney's Office recommend the claim be compromised for the total sum of \$6,349.89, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$6,349.89 made payable to Radio Cab.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.


