

ORDINANCE No. 187963

*Accept a grant in the amount of \$852,000 and authorize an Intergovernmental Agreement with the Oregon Department of Transportation for the Planning and Development Phase of the Portland Central City Multimodal Project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Portland Bureau of Transportation applied to Metro for a grant in the amount of \$6,000,000 for Central City Multimodal Safety Improvements on March 15, 2013; and
2. Portland's Central City is the region's economic hub, with the densest concentration of jobs and people in Oregon; and
3. The Central City Multimodal Project will help make getting to and around the Central City safer, easier, and more convenient by foot, bike, and transit through the construction of active transportation projects; and
4. Due to the complexity of and increasing demands on transportation infrastructure in the Central City, a planning and development phase is required for this effort, including robust opportunities for public and stakeholder involvement; and
3. The Oregon Department of Transportation has notified the City of Portland that it will award a grant for the Planning and Development Phase of the Central City Multimodal Project to the Portland Bureau of Transportation in the amount of \$852,000;

NOW, THEREFORE, the Council directs:

- a. The Commissioner-in-Charge is hereby authorized to accept on behalf of the City of Portland a grant from the Oregon Department of Transportation for the Central City Multimodal Safety Improvements in the amount of \$852,000 and to execute an Intergovernmental Agreement in a form similar to the contract attached as Exhibit A.
- c. The Commissioner-in-Charge is authorized to execute amendments, approved as to form by the City Attorney, to the scope of the services or the terms and conditions of this Agreement, provided the changes do not increase the City's financial risk. Increases to the grant amount must be approved by the City Council.
- d. The OMF Grants Office is authorized to perform all administrative matters in

relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Commissioner-in-Charge's behalf.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
