## ORDINANCE No. 187984

Expand the authority of the Risk Manager and designees to serve as agents of the City Attorney to investigate and settle tort claims and clarify the scope of fair and moral claims for which the Risk Manager is authorized to investigate and settle (Ordinance; amend Code Section 3.15.020 G.)

The City of Portland ordains:
Section 1. The Council Finds:

1. Subsection 4 of Portland City Code Section 3.15.020 G. authorizes the Risk Manager to investigate complaints of discrimination filed with the Civil Rights Division of the Oregon Bureau of Labor and Industries or the Equal Employment Opportunity Commission; and states that during the investigation, the Risk Manager and their designees are agents of the City Attorney for purposes of representing the City.
2. Other subsections of PCC 3.15.020 G. authorize the Risk Manager to act on behalf of the City on all matters related to workers' compensation, and in the settlement of tort claims and court actions alleging discrimination and violations of civil rights.
3. Existing City Code language does not specifically state that, during the investigation of tort claims, the Risk Manager and their designees are agents of the City Attorney, except in complaints of discrimination as discussed above.
4. The City Attorney recommends that it is in the City's interest to expand the authority of the Risk Manager and their designees as agents of the City Attorney to include all tort claims for which they are responsible for investigating, evaluating, settling and or making recommendations regarding settlement.
5. Charter Section 1-107 establishes the authority of the City to evaluate and settle fair and moral claims brought against the City.
6. Subsection 5 of City Code Section 3.15.020 G. authorizes the Risk Manager to investigate and enter into settlements on fair and moral claims not covered by insurance, but does not otherwise describe or limit fair and moral claims.
7. PCC 3.15.020 G. should be amended to clarify that the Risk Manager has the authority to investigate and settle fair and moral claims as they are described in the Charter.

NOW, THEREFORE, the Council directs:
a. PCC 3.15.020 G. is amended as shown in Exhibit A.
