Purpose of proposed legislation and background information:

This legislation will authorize the Chief of Police or designee to execute revenue generating police secondary employment contracts. The Portland Police Bureau (PPB) historically has provided police personnel for hire to businesses for onsite public safety during events or other public gatherings.

During Lt. Schober's policy and ordinance research of the police secondary employment it was discovered that in fact no actual ordinance covered the current practice of bureau commanders authorizing and signing most police secondary employment contracts. This proposed ordinance was drafted to rectify the issue.

This legislation does not change any City policies.

No revenues will be impacted by this legislation.

Financial and budgetary impacts:

There is no financial or budgetary impact associated with this action. As revenue generating agreements, all are written to cover the officer's wages and administrative overhead for providing services to the contracting business. The proposed ordinance will allow PPB to efficiently execute agreements with local businesses desiring to hire police through the secondary employment agreements in a streamlined process that is fair and equitable for all community members of City of Portland. By having the Chief of Police or designee authorized to execute agreements for police secondary employment will allow the PPB to immediately respond to requests from the business community, expedite the short-term agreements and create a more efficient response by the PPB. This will allow the PPB to be more agile in fulfilling police secondary employment contracts while relieving the effects and burdens created by private business events that generate police calls for services. The standard agreement for these services has been approved for use by the Portland City Attorney's office; all future agreements will continue to utilize this form.

No present positions will be created, eliminated or re-classified as a result of this legislation.

Community impacts and community involvement:

The police secondary employment agreements will have the net result of increasing the availability of regular patrol officers by minimizing the need for patrol units to respond to calls

generated by private business events that alternatively pay for police secondary employment services for their events. These actions increase the availability of regular patrol officers to respond to 911 calls for services in the communities throughout the City and relieves geographic area and neighborhood stresses by allowing regular patrol officers to remain in these areas.

The added officers are hired on overtime independent of the staffing of regular patrol.

No known persons or groups will be testifying.

No future public involvement is anticipated or necessary for this request as these goods and services will be used on an internal City system.
