## ORDINANCE No. 188031

\*Authorize a one-year lease extension for \$12,925 with the Oregon School Boards Association and the League of Oregon Cities for the Office of Government Relations to lease space at 1201 Court Street, SE, Suite 400, Salem known as the Local Government Center through June 30, 2017 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Office of Government Relations ("the Office") requires space located near the State Capitol to support the operations of the Director and the State Legislative Relations Team.
- 2. The mission of the Office is to advance the City of Portland's legislative and intergovernmental policy objectives. The Office provides effective representation, strategic advice, and quality service to the City Council and all city bureaus.
- 3. The City of Portland rents office space in Salem to support advocacy of the City's legislative agenda. And the City's bill tracking system is based out of the Salem office.
- 4. The Office would like to extends its lease for approximately 554 square feet from the Oregon School Boards Association ("OSBA") and the League of Oregon Cities ("LOC") located in certain space at 1201 Court Street, SE, Suite 400, Salem, Oregon, commonly known as known as the Local Government Center.
- 5. Annual lease is \$12,925.44. Resources are allocated in FY 16-17 budget.

NOW, THEREFORE, the Council directs:

a. The Director of the Bureau of Internal Business Services or his designee is authorized to execute documents as necessary, once approved as to form by the City Attorney, for the lease at 1201 Court Street, SE, Suite 400, Salem, Oregon, for a one-year period through June 30, 2017.

Section 2. The Council declares that an emergency exists in order that this lease agreement may occur without delay; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
