# Housing Emergency Community Engagement Plan Office of Neighborhood Involvement

This is a proposal for organizing a collaborative community engagement process between ONI, its community partner organizations, A Home for Everyone, City and County Joint Office for Homeless Services, City and County elected officials.

# What City Council approved

*From Council 2016-2017 Budget Hearing, Wed. May 18, 2016:* Motion to amend Attachment B to add the following budget note regarding Office of Neighborhood Involvement and Portland Housing Bureau's housing emergency outreach and engagement: Moved by Fritz and seconded by Hales.

Office of Neighborhood Involvement/Portland Housing Bureau – Housing Emergency Outreach and Engagement: (As further amended.) Council directs the Office of Neighborhood Involvement to work with the Portland Housing Bureau, the City and County Joint Office for Homeless Services, and A Home for Everyone to develop materials and messaging for community engagement on housing prior to spending the \$350,000 allocated in its budget for this purpose. The Office of Neighborhood Involvement will return to Council for approval of the outreach plan before funds are expended.

## **Problem statement**

Many in the community, especially those with lived experience with being houseless and lowincome residents who are at-risk of becoming houseless, have historically not had an active presence in government decision making processes with a direct impact on their lives. In addition, many community and neighborhood activists have identified a need for more public information about the City's strategy for addressing the housing crisis and opportunities for community engagement to be a constructive part of the solution to housing instability in Portland.

## Why this proposal?

As the housing crisis grows and more people are pushed to the edge, community members are increasingly seeking resources and support in addressing the impacts of houselessness and housing insecurity. The Office of Neighborhood Involvement is exploring ways to support and partner with community-based organizations, neighborhood groups, and grassroots community groups in finding ways to address this crisis on the ground as well as having a voice in long-term policy solutions.

# **Proposed Goal statement**

This project will provide resources for community and neighborhood groups to affect the current housing crisis and its impacts on our communities and neighborhoods, particularly engaging individuals and improving the lives of people experiencing housing insecurity and houselessness. These resources will be used for outreach and information sharing in coordination with relevant government agencies about the City and County's action plan, building community and neighborhood-based organizational capacity including leadership development and public policy advocacy efforts, and, funding small grant projects to engage more people in creative community-based projects addressing the housing crisis.

#### Proposed values guiding this work

ONI has identified a set of values, embodied in our bureau goals, to help shape and prioritize our work and the community efforts we will support:

- 1. **Collaboration:** Working together creates solutions to community issues that are more effective, lasting, and truly inclusive grounded in mutual compassion for each other.
- 2. **Community leadership:** Those most directly affected by the issues should be an active part of determining solutions to the issues, and our work should include those voices; in this case, the voices of the houseless communities.
- 3. **Diversity:** Our communities are diverse and that diversity should be reflected in our work. Houseless people are our neighbors, are part of our communities, and have a stake in the neighborhood too.
- Equity: Those that have been given the least access to decision making and involvement should be actively engaged in the work, in this case all people experiencing visible or less visible houselessness.

## Proposed Project Outcomes

- Community-based organizations working with individuals and families experiencing housing insecurity and houselessness have expanded capacity to be able to engage people and provide a forum for the community to express their concerns, needs and problems that need to be resolved, and effectively organize to build power to affect policy change and long-term solutions towards ending the City's housing emergency.
- A community more informed about A Home for Everyone's action plan A United Community Plan to End Homelessness for Portland/Multnomah County and opportunities to engage in constructive efforts to end the City's housing emergency.
- 3. ONI's partner organizations have **expanded capacity to collaborate** with communitybased organizations and government agencies to inform, provide a forum, engage, and organize their constituencies to affect policy change and long-term solutions towards ending the City's housing emergency.

## **Proposed strategies**

- Leadership development Building skills among people affected by houselessness or at risk for being unhoused so they can self-advocate and organize on housing public policy, budget processes, responding to eviction notices, long-range land use planning processes, building coalitions with other community groups and working collaboratively with government.
- Policy development Engaging community members with lived experience with the crisis, neighborhood and other community constituencies in developing and advocating to affect public policy at local, state and federal levels. Also seeking community and neighborhood representation on and engagement with City and County advisory committees, boards, and commissions related to this issue.
- Community organizing Identifying and creating opportunities for community members to contribute constructively to solutions such as organizing community forums, building membership base to engage in advocacy efforts, coordination of engagement activities amongst ONI partners and other grantees working on this project, recruiting volunteers to work on projects in coordination with government and community organizations.
- 4. Information coordination and communication Project grantees work together with A Home for Everyone and the City and County Joint Office for Homeless Services to inform the public about the Action Plan to End Homelessness for Portland/Multnomah County, the Mayor's Homelessness Toolkit, One Point of Contact, campsite cleanup info, and opportunities to engage in efforts to end the housing emergency.

# Proposed project coordination

- **Project coordination** An ONI partner grantee will supervise a staff coordinator of community outreach efforts, collection of information from policy makers and distribution to project partners, and competitive small grants process.
- Coordinating team ONI will organize a workgroup with all grantees to meet on a regular basis and report back to ONI Bureau's Advisory Committee. Include representatives from A Home for Everyone and elected officials.
- **Competitive grant process** Seek Letters of Interest and include AHFE, community and Council staff representation on grant review committee.
- **A Home for Everyone coordination** Identify opportunities for regular involvement with AHFE and its committees to support more coordinated information sharing.
- **Project administration** ONI staff to coordinate contract, financial and performance measure administration and generally keeping project on track and ensure coordination with related City and County public involvement efforts.
- **Performance measures** Will include accountability measures based on quantifiable objectives such as how many people are involved, how many people are trained, etc.
- **Distribution of information** Grantee organizations will work closely with staff coordinator and AHFE and City and County Joint Office for Homeless Services on a communication strategy.
