Re: Appoint a Pool of Community Volunteers to be Available to Serve on the Police Review Board

In 2010, Portland City Council amended City Code 3.20 which governs the processes and make up of Portland Police Bureau's performance and use of force review boards. As part of the changes approved by Council, the Police Bureau will select citizen members for the Police Review Board from a pool of volunteers recommended by the City Auditor and appointed by City Council.

My recommendations for appointment are listed below, and brief biographies are attached. Staff from the Auditor's Independent Police Review division, a member of the Citizen Review Committee, and a Police Bureau member assisted in the selection of the pool of community volunteers available to participate in Police Review Boards convened after October 31, 2013. If confirmed by Council, their term begins October 31, 2016 and ends October 31, 2019.

Isaura Ascensio

Isaura Ascensio is the Anti-poverty Supervisor for the Youth & Family Services division at Multnomah County's Department of Human Services where she oversees multiple programs related community development, housing stability, runaway youth, faith-based partnerships, and many others serving the most vulnerable. Previously she had also served as the Community Engagement Coordinator where her skills in building partnerships helped support grassroots efforts around civic participation, conversations on policing, small business development, and barriers to legal representation for low-income families and the immigrant/refugee communities.
