

ORDINANCE No. 188071

* Accept a grant in the amount of \$393,412 and appropriate \$100,000 for FY 2016-17 from the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Statistics Federal FY 2016 National Crime Statistics Exchange Implementation Assistance Program for the Regional Justice Information Network to transition to National Incident-Based Reporting Systems (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The City was invited to apply for the U.S. Department of Justice (DOJ), Office of Justice Programs (OJP), Bureau of Justice Statistics (BJS) FFY 2016 National Crime Statistics Exchange (NCS-X) Implementation Assistance Program: Phase III, which will award grant funding to support efforts of local law enforcement (LE) agencies with 750 or more sworn officers to report incident-based crime data to the FBI's National Incident-Based Reporting System (NIBRS) through their state NIBRS-certified Uniform Crime Reporting (UCR) Program;
2. The City submitted their grant application on June 8, 2016. The Office of Justice Programs notified the City on September 28, that they will award a grant, in the form of a cooperative agreement, for the BJS FFY16 NCS-X Implementation Assistance Program: Phase III to the City in the amount of \$393,412;
3. The Office of Justice Programs will reimburse the City a maximum of \$393,412 for program expenses incurred by the Police Bureau.
4. The grant period is October 1, 2016, through September 30, 2018;
5. No match is required by this grant; and
6. Council declares an emergency exists because a delay would jeopardize the awarding of the grant funds from DOJ.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City a grant from OJP for the BJS FFY16 NCS-X Implementation Assistance Program: Phase III in the amount of \$393,412 and to execute the grant agreement.
- b. The FY 2016-17 budget is hereby amended as follows:
GRANTS FUND
Fund - 217
Business Area - PL
Bureau Program Expenses - \$100,000

- c. The Office of Management & Finance Grants Division is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
- d. The Chief of the Police Bureau of the City of Portland is authorized to accept on behalf of the City of Portland any subsequent modifications for the BJS FFY16 NCS-X Implementation Assistance Program: Phase III grant program, #2015-FU-CX-K055, provided such modifications do not increase the City's financial obligation or risk. Any modifications that increase the City's financial obligation or risk must be authorized by Council.





