ORDINANCE No. 188104

* Amend the FY 2016-17 Revised Budget to include additional funding for City Council Office transition work in the amount of \$76,499 (Ordinance)

The City of Portland ordains:

Section 1. The Council Finds:

- 1. City Council has a long-standing practice of authorizing funding for limited staff support for incoming Council members in order to support an effective transition for City operations.
- 2. The Office of Management & Finance serves as the Council transition coordinator and requested funding for one Council Office transition in the FY 2016-17 Requested Budget in Special Appropriations.
- City Council approved funding for one City Council transition in the City FY 2016-17 Adopted Budget.
- 4. There is now a need for additional funds to support a second Council transition; therefore additional funding is requested.
- 5. The General Fund unrestricted contingency balance of \$1.47 million in the current year is sufficient to fund the identified expenses.

NOW, THEREFORE, the Council directs:

a. The FY 2016-17 Appropriations Schedule is hereby amended as follows:

Special Appropriations Fund – 100 Business Area – SA Bureau Program Expenses - \$76,499

Fund Management Fund – 100 Business Area – FM Contingency – (\$76,499)

b. The actions amending the FY 2016-17 budget contained in this ordinance are binding City policy.

Section 2. The Council declares that an emergency exists because the City lacks the necessary current year budget appropriation to facilitate an orderly transition for City operations; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
