Why am I receiving this notice?

You are receiving this notice because you have expressed interest in learning about certain Bureau of Planning and Sustainability projects, you are on one of our advisory groups, or you are a member of a neighborhood association or a member of a business association.

What is this project about?

The City of Portland is updating its Comprehensive Plan, a 20-year plan for the physical development of the city. The Plan has several parts: Goals and Policies, Plan Map, Citywide Systems Plan, Significant Projects List, and Transportation Systems Plan.

How can I review the plan?

Proposed drafts of the 2035 Comprehensive Plan Goals and Policies, the Comprehensive Plan Map, and the Citywide Systems Plan are available now at Multnomah County Branch Libraries, at Neighborhood Coalition Offices and on the web at <http://www.portlandoregon.gov/bps/compplan>. You may also pick up copies at our office at 1900 SW 4th Avenue, 7th Floor. Additional materials related to the Significant Projects List and the Transportation Systems Plan will be available before October 25, 2014. All documents will be posted at <http://www.portlandoregon.gov/bps/compplan> as they become available. You may also view proposed changes to the Plan Map with the interactive Map App at www.portlandoregon.gov/bps/mapapp on any computer, tablet or smart phone. Begin by typing in a property address.

How can I comment on the plan?

You may comment any time between now and November 4, 2014. Oral testimony is welcome at the four hearings listed on the other side of this notice. Written testimony may be mailed to: Portland Planning and Sustainability Commission, Comprehensive Plan Update, 1900 SW 4th Avenue, Suite 7100, Portland, OR 97201; or submitted electronically to: pdxcompplan@portlandoregon.gov with the words *PSC Comprehensive Plan Testimony* in the subject line. You may also use the Map App www.portlandoregon.gov/bps/mapapp to comment on the proposed draft map. For your comments to be included in the Planning and Sustainability Commission's official hearing record, you must provide your legal name and mailing address. Whether or not you provide your name and address, your comments will be considered.

What happens next?

The Planning and Sustainability Commission will consider public comments on the Comprehensive Plan Update. After their last public hearing the Commission will forward their recommendations to the Portland City Council for possible approval and adoption. There will be more public hearings and opportunities to comment before City Council in 2015. The 2035 Comprehensive Plan update will not take effect unless and until the City Council adopts them by ordinance and the Oregon Land Conservation and Development Commission approves them by order.
