ORDINANCE NO. 130831

An Ordinance designating certain buildings in the Northwest section and the Southwest section of the City of Portland as "Historical Landmarks", and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that the Portland Landmarks Commission created by Ordinance No. 127512 (Article 48 of the Planning and Zoning Code) has completed a survey of historical buildings in the City and has adopted a list of 6 buildings in the northwest section and 25 buildings in the southwest section of the City to be submitted to the Council for designation as "Historical Landmarks"; that buildings in the Skidmore Fountain Area and certain other buildings in the northwest and southwest sections of the City have previously been designated as "Historical Landmarks, by Ordinances No. 130148 and 130627, and that subsequent groups of buildings will also be submitted to the Council for such designation by geographic location in order to facilitate admistration of the program; that the order of submission in no way reflects on the relative merit of any building or group of buildings to be so designated; that a hearing of owners of the selected buildings was held by the Council on April 8, 1970 (Council Calendar No. 1259) for consideration of the designation, and at said meeting all remonstrances and objections made or filed were heard and considered by the Council; that thereafter one building so recommended by the Historical Landmarks Commission to be so designated, No. 3-24,409 S.W. Fifth Avenue, Portland, was returned to the Commission for further study; that thereafter all remonstrances were specifically overruled; now, therefore, the buildings set forth herein are designated as "Historical Landmarks", and the Auditor hereby is authorized to send a copy of this ordinance to the owner or agent of each building, and the Auditor is directed to have a copy of this ordinance recorded in the Deed Records for Multnomah County:

Section 2. The building legally described as 1/4 Sec 3028, Lots 1, 2,7 and 8 No 1/2 of Block H, Portland, located at 1200 S.W. Alder Street, Portland, Oregon - Owner First Presbyterian Church, S.W. Alder at 1200, Portland, Oregon, is designated as an historical landmark.

ORDINANCE No.

Section 3⁰. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that there may be no delay in carrying out the desires of the Commission, all in the public interest; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
