ORDINANCE NO. 188416

Authorize a contract with Carollo Engineers, Inc. in an amount not to exceed \$291,852 for design and construction support services for the Conduit 2 Trestle Upgrades Project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Water Bureau needs to retain the professional, technical, and expert services of an engineering consultant for the design and construction support services for the Conduit 2 Trestle Upgrades Project (Project).
- 2. This Project is justified by the business case analysis completed as part of the 2015 Conduits Rehabilitation Plan. The Project mitigates Conduit 2 failure risks at the Beaver Creek Tributary and the El Camino Trestles due to both seismic and flooding events and will improve the Water Bureau's supply resiliency due to natural disasters.
- 3. A formal Request for Proposal 00000433 was advertised by City Procurement in accordance with Chapter 5.68 of the Code of the City of Portland. One proposal was received. Carollo Engineers, Inc. was deemed responsive and qualified for this Project. The contract amount is \$291,852.
- 4. The estimated average Oregon State-certified disadvantaged, minority, women, and emerging small businesses participation on this contract is \$74,200 or 25.4% of the total contract dollars.

NOW, THEREFORE, the Council directs:

- a. That the Chief Procurement Officer is authorized to execute on behalf of the City a contract with Carollo Engineers, Inc. for the Conduit 2 Trestle Upgrades Project in an amount not to exceed \$291,852 and in a form substantially in accordance with the contract attached as Exhibit A.
- b. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the Water Fund when demand is presented and approved by the proper authorities.
