## ORDINANCE No. 188544 As Amended

\*Extend contract with Fastenal Company through June 30, 2018 for City-wide facilities maintenance, lighting products and industrial supplies (Ordinance; amend Contract No. 31000508)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Office of Management and Finance, Bureau of Revenue and Financial Services, Procurement Services is responsible for developing and managing participating agreements as part of its on-going strategic sourcing efforts.
- 2. On March 1, 2014, the City entered into participating agreement #31000508 with Fastenal Company through a State of Oregon cooperative contract, for a not-to-exceed amount of \$2,100,000.
- 3. On February 9, 2017, the State of Oregon amended the cooperative contract to extend it through June 30, 2017. On March 1, 2017, the City amended the participating agreement to match the State's contract and added \$233,333 in compensation.
- 4. On March 12, 2017, the State of Oregon amended the cooperative contract to extend it through June 30, 2018.
- 5. Amending the City's participating agreement with the State of Oregon by extending Price Agreement 31000508 with Fastenal to June 30, 2018 will allow the City to continue its efficient and cost effective ordering of facility maintenance and industrial supplies to meet its operational needs.

NOW, THEREFORE, the Council directs:

- a. The Chief Procurement Officer is authorized to amend this Price Agreement to extend the expiration date to June 30, 2018.
- b. The Mayor and City Auditor are hereby authorized to pay for said purchases chargeable to the appropriate authorization and accounting centers when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists because delay in proceeding with this amendment may result in extended wait times or higher pricing on facilities

maintenance, lighting products and industrial supplies used City-wide on a regular basis. Therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
