

STREET SWEEPING IN PROJECT AREA

After meetings with Commissioner William A. Bowes and Street Sweeping Supervisor, Frank Woodruff, ANIC learned that an adequate sweeping schedule is being carried out on Project Area streets.

Kerby Avenue (Fremont to Skidmore) and Shaver Street (Mississippi to Commercial) are hard-surface streets that are being mechanically swept once every 14 working days. All other streets, which are oil-bound macadam, are being swept six times per year. This sweeping schedule is the one which is carried out in all other residential neighborhoods of the city.

The picture at the right illustrates the type of sweeper that is used and shows the operator, Mr. Isaac Harpole, on his scheduled run on Kerby Ave.

At present, the ANIC staff is working with Mr. Woodruff to see if signs can be placed on the Project Area streets one day before the sweeping is to take place. This procedure will enable property owners to obtain better sweeping service by removing cars from the streets on sweeping days.



74 TREES ORDERED

ANIC's Tree Program Committee met on January 20 and January 23 to evaluate the status of the Tree Program and to develop a final plan for obtaining necessary tree orders to conduct a large-scale planting by mid-March.

At the January 20 meeting, it was learned that monies for 74 new trees had been collected and that these tree orders had come from owners throughout the Project Area. Also, all tree trimming and removing activities of large overgrown trees had been completed by the utility companies at a cost of about \$8,000 to Portland General Electric and Pacific Power and Light Companies.

The members discussed the fact that the 74 new trees, plus the 25 trees already planted in the two demonstration blocks, totaled 20% of the trees included in the Planting Plan. Therefore, it was agreed that trees already ordered should be planted immediately and that additional orders should be obtained as quickly as possible to effectively demonstrate the beauty of an over-all planting program.

On January 23, the Tree Committee members met with Mrs. Joseph Crane, Mrs. Mamie Bowles, Mrs. Maggie Young, Mr. Willie Williams, Mr. and Mrs. Len Soneson and Rev. Wendell Wallace, who volunteered to help. These volunteers will work with the Tree Committee members on a team basis and will be calling on those property owners who had not previously been contacted.

Street Lights. The Tree Subcommittee also discussed the need for getting the new street lights installed. The group was reminded that the Tree Program had been coordinated with the trimming of trees and cleaning of old poles and wires so that the new lights would be effective when installed. Now that the trees have been trimmed, Mr. Fred Hamilton, City Street Light Engineer, has reinstated the order. The start of installing lights in the middle of Project Area blocks has been promised by Portland General Electric during February.

INDIVIDUAL ASSESSMENT DISTRICT ESTIMATES BEING PREPARED


Members of ANIC's Executive Board met with Commissioner William A. Bowes and representatives of the City Engineer's and City Auditor's offices on January 8 and finalized plans for obtaining individual cost estimates under the proposed Assessment District.

It was agreed that the estimates would only be computed for improvements to alleys, curbs and sidewalks. The complete resurfacing of streets was discussed and this improvement proposal was eliminated from the Assessment District Proposal. The main purpose of this proposal was to obtain adequate sweeping in the Project Area; at least comparable with that of other similar neighborhood areas of the city. Since the city has stated that the oil-bound macadam streets in the Project Area will be swept six times per year and the hard surface streets every 14 working days, the complete reconstruction of streets to provide a hard-surface material does not now appear necessary.

Under the current agreement, the City Engineering Department will furnish the City Auditor's Office with specifications and estimates so that the Auditor's office can compute the exact costs as they pertain to each property owner. When the compiling of this information is complete, the individual costs will be mailed to each property owner. It is expected that the required public hearing on the Assessment District will be held within 30 days after all property owners receive this information.

The Albina Neighborhood Improvement Committee will hold a General Neighborhood Meeting to further discuss the Assessment District with the residents of the area. The date of this will be announced at a later time.

The Committee is also planning to sponsor a series of block meetings after property owners receive their cost estimates to further discuss the Assessment District and answer any questions that residents might have. Everyone will be informed by letter of the date and time of these block meetings shortly after the cost estimates have been mailed.

ANNA DUDLEY-ALBINA PIONEER



ANIC APPROVES PROCEDURE FOR OBTAINING CITY COUNCIL APPROVAL OF PROJECT PLAN

The members of the Albina Neighborhood Improvement Committee, at their meeting on February 6, 1964, approved a procedure for obtaining the Portland City Council's approval of the Project Plan.


The Committee's original thought was to obtain this approval at a public hearing date when both the Plan and the Assessment District proposal could be reviewed and approved. Upon reaching this necessary local government approval, all data was then to be sent to the Federal Government for final approval.

Because the work in putting the Assessment District together is taking longer than anticipated, the Committee recommended that the public hearing on only the Project Plan be held at this time and if approved sent to the Federal Government for review. This review by the Federal Government can then be made while the work is still progressing on the Assessment District. Such a procedure will enable the Project review to be completed while the estimates are being prepared and save 2 or 3 months in getting final authorization to proceed from the Federal Government. Of course, Federal Government participation will be dependent upon local approval of the Assessment District.

The Portland Development Commission and the City Planning Commission are scheduling to review the Project Plan before it is sent to the City Council for the public hearing. It is anticipated that the hearing on the Plan will be placed on the Council's calendar within one month and all property owners in the area will be notified of the time and date of the hearing.

ADDITIONAL BLOCK REPRESENTATIVES APPOINTED

The following property owners in the Project area were appointed ANIC Block Representative during the past month: Mrs. James Lawrence, Block 11; Rev. F. J. Crear, Block 34; Mr. Burrell Williams, Block 16; Mr. James Crolley, Block 30; and Mrs. Phene Houston, Block 32. The Committee is very happy to have the opportunity to work with these persons on Project activities and appreciates their acceptance of the appointment.

The Tree Program Subcommittee met on February 13, and learned that 120 trees had been ordered to date.


A map showing the families who had ordered the trees was reviewed and it revealed that some blocks were still lacking in orders placed.

Mr. Mellott, owner of the nursery, had previously worked with ANIC and agreed to supply the trees to the Project area at \$5.00 per tree. The type of trees to be planted were viewed first hand by the group and the general over-all planting procedure was discussed.

DEVELOPMENT COMMISSION APPROVES PLAN AT MARCH 16 MEETING

The Portland Development Commission approved the Urban Renewal Plan for the Albina Project at their regular meeting on March 16, 1964. The Commissioners, Ira C. Keller, A. V. Fonder, Vincent Raschio, Russell Colwell and Harold Halvorsen, by their action committed \$508,585 as the local share for financing the Project. Although approving the Project, the Commissioners directed the staff to work with ANIC and neighborhood property owners to assure that acquisition of property be kept to a minimum.

The City Planning Commission held their review on March 17, 1964, and approved the Plan as being in conformance with the Comprehensive Plan of the City.

SIGNS TO BE PLACED ON PROJECT AREA STREETS ONE DAY PRIOR TO STREET SWEEPING

The plan for placing signs on Project area streets one day prior to the scheduled street sweeping has been worked out with Mr. Frank Woodruff, City Street Sweeping Supervisor.

The City maintenance crews will place the sign barricades in the parking strips as a reminder to property owners that the streets will be swept the next day. Property owners are asked to have their cars removed from the streets on the sweeping day so that the sweepers will be able to do a better job.

These barricades will be placed on all north-south streets on Monday, March 30, and the sweeping will take place on Tuesday, March 31. The east-west streets will be posted on Tuesday, March 31, and swept on Wednesday, April 1.



151 NEW TREES PLANTED

Planting of 151 Kwan-zan flowering cherry trees began on March 19 and the entire planting was completed on March 20.

PGE and PP&L furnished hole digging crews and the trees were planted by Norman Hutchens, Lester Smallwood, and Leonard Rogers of the Carlton Nursery Company.

The planting was carried out in accordance with ANIC'S Tree Program Plan and was in conjunction with the spring planting phase of the plan.

Property owners who have not purchased trees to date may do so by contacting the Information Center or members of the Tree Program Subcommittee. Trees purchased after March 27 will be planted during the fall planting season.

PUBLIC HEARING ON ALBINA URBAN RENEWAL PLAN SET FOR APRIL 8

The required public hearing on the Urban Renewal Plan will be held on Wednesday, April 8, 1964, at City Hall in the Council Chambers.

At the last regular monthly neighborhood meeting at Boise School, it was explained that ANIC recommended the public hearing be held on the Plan as soon as possible, and, if locally approved, sent to the Federal Government for review. This review could then be made while the City Engineer completes estimates for repair of curbs and sidewalks and paving of alleys under the proposed Assessment District.


Block leaders at various meetings (picture below) have discussed the opportunity to begin the Project this summer rather than next winter. By having the hearing on the Plan now, the Federal Government can complete reviews by the time the hearing is held on the Assessment District. If the Assessment District is approved, the Plan can be approved and work can begin this summer.

ANIC Block Representatives have also been visiting with property owners in the area during the past week to explain to property owners (1) the meaning of the Plan; and (2) how it will enable the Improvement Project to be carried out. A signature sheet is also being used by the Block Representatives as a means of indicating how many people favor the Project and to encourage favorable City Council action following the public hearing.



All property owners and residents of the area will have an opportunity to further discuss and ask questions about the Plan and the public hearing at the next regular monthly neighborhood meeting. This meeting will be held on Thursday, April 2, 1964, at Boise School at 8:00 p.m.

Everyone is encouraged to attend this meeting and all property owners are urged to sign the signature sheets that are being circulated in the area so that ANIC can make a formal presentation to the City Council for approval of the Plan.

STREET LIGHTS INSTALLED IN PROJECT AREA

CITY COUNCIL APPROVES ALBINA PLAN



The City Council approved the Project Plan for the Albina Project at the April 8, 1964 public hearing. Mr. John B. Kenward, Executive Director of the Portland Development Commission, opened the presentation by reviewing the elements of the project for the Council. The following ANIC members addressed the Council and urged approval of the Plan: Rev. R. Rogers, Mr. E. H. Thiel, Mrs. Joseph Crane, Mr. Herbert Lewis, Rev. F.J. Crear, Mr. Len Soneson, Mr. Chas. Young, Rev. W. Wallace and Mrs. W. Hintermeister. Mrs. Ruth Ball and Miss Eloise Williams also supported the Plan.

After considerable discussion regarding the park site and other elements of the Plan, the Plan was unanimously approved. This approval enabled the Portland Development Commission to submit the final documents to the Federal Government so that reviews can be completed by the time the public hearing is held on the Assessment District. If the Assessment District is approved a contract can be signed with the Federal Government and the project can officially begin.

PETITION COMPLETED

The effort by numerous Block Leaders and other ANIC workers to explain the Project Plan and gain signatures of people in favor of the Project was completed and reported to the City Council at the Public Hearing on April 8.

Owners of 239 structures signed the form: This included 73% of the resident owners. ANIC workers only found 2% of the people uncooperative. Others were not at home when visits were made.

A petition to oppose the development of the park was presented to the City Council by Mrs. Zelavic. The 129 signatures on her petition represented 93 structures and only 38 owners and 7 tenants had not later signed the ANIC petition favoring the Plan.

PORTLAND DEVELOPMENT COMMISSION STATES POLICY

Following action of the Portland City Council, members of the Development Commission authorized submission of the Plan for the Albina Project to the Federal Government. The package was mailed on April 27, 1964.

At their meeting on April 13, the members also approved a Resolution to make clear to project area residents that the Development Commission will not proceed with the project as presently planned unless the Assessment District for repair of curbs and sidewalks and paving of alleys is approved.

As reported earlier, the individual estimates of cost are being prepared by the City Engineer and the City Auditor. A public hearing will be set as soon as the information is completed and costs can be discussed by owners at meetings in the Project Area.

BLOCK 29 HOLDS SECOND ALLEY CLEANUP

The second alley cleanup project was held in Block 29 on April 11th. Property owners were not able to raise enough money to pay for the removal of two truck loads of debris in January so, as Mrs. Slider reported, they organized to have the remainder of the debris hauled away at this time. This system enabled the owners to spread the \$10.00 cost per truck load out over three months and still were able to adequately clean the alley.

The Information Center staff will work with all block groups in setting up the cleanups and all block groups are urged to make arrangements for their cleanups now that Spring is here.



ANIC LEARNS ABOUT YOUTH EMPLOYMENT PROJECT



Due to great general interest in youth employment, ANIC invited Mr. Guy Lang and Mr. James Osman of the State Employment Service to speak at a special meeting on April 23, 1964.

Mr. Lang and Mr. Osman stated they were trying to learn how many young persons are in need of a program of job training which would qualify them for specific jobs.

In order to be considered for this training program

a young person would have to be:

1. At least 16 years old but under the age of 22.
2. Out of school.
3. Unable to find a full time job because he/she does not have the right type of training.

The job training would be free and could:

1. Enable youth to learn skills which would qualify him or her to obtain such positions as; stenographer, dental assistant, service station attendant or other employment.
2. Allow, in some cases, up to \$20.00 per week while training.
3. Enable the State Employment Service to assist the young person in finding a job after the training is completed.

Mr. Lang and Mr. Osman stated that these training courses will be held at various local schools and the training period will range from two weeks to a full year depending on the courses. Mr. George Gearheart was introduced as the man in charge of setting up the courses in Portland. ANIC agreed to support the program and those attending the meeting agreed to circulate application forms to young persons who they thought might be interested. These forms are also available at the Information Center. Anyone wishing more information should call the office (AT2-2214). Pictured above is Rev. CITY ENGINEER COMPLETES SPECIFICATIONS FOR ASSESSMENT DISTRICT

The City Engineer's office completed the specifications and plans for alley paving and curb and sidewalk repair on May 14, 1964, and on May 20, 1964, the City Council authorized the City Auditor to advertise for bids.

The following general steps must be carried out by the City Auditor, in accordance with existing City ordinances, before the public hearing on the Assessment District can be held:

1. Receive and open bids.
2. Declare low bidder.
3. Compute exact assessment cost as it applies to each property owner.
4. Mail letter of cost to each owner.
5. Set remonstrance period of 33 days.

It is now estimated, due to the timing involved, that the public hearing will be held during the month of August.

COLLECTIONS STILL CONTINUING FOR TREES SOLD

Rev. F. J. Crear, Chairman of the Tree Program Subcommittee, reported that collections are still being made for the trees sold in accordance with the Project Tree Program plan.

The Subcommittee authorized the mailing of a statement to those still owing for trees and the response to the billing has been good. He urged that those who have still not sent in their money to do so immediately to permit ANIC to pay the bill from Carlton Nursery.

POSTING TO CONTINUE ONE DAY PRIOR TO STREET SWEEPING

City maintenance crews will place the barricades in parking strips again this month as a reminder to property owners that the streets will be swept the next day.

Owners of cars are asked to remove their cars from the streets on the sweeping day so that the sweeping crews can do a good job.

The barricades will be placed on all north-south streets on Monday, June 1, and the sweeping will take place on Tuesday, June 2. The east-west streets will be posted on Tuesday, June 2, and swept on Wednesday, June 3.

CITY AGENCIES AND LOCAL SCHOOL REPRESENTATIVES AGREE TO
WORK WITH ANIC IN AREAS OF INTEREST AND CONCERN

ANIC members met at the Information Center on May 19, 1964, to discuss vandalism in the Project area. Those attending included:

It was suggested that parents can do the most to curb vandalism by talking and working out existing problems with representatives of local churches, welfare departments, the police department, and counselors from the local schools.

Captain Purcell related that all communities are faced with problems of vandalism and he assured ANIC that he would work with the people of the area in every way possible to insure that a positive approach would be taken on this problem in the area.

It was agreed by all that one of the biggest problems which help create vandalism is the lack of community-sponsored programs for children.

Mr. John Burch stated that his agency would also cooperate in every way possible, and he would provide counseling service at block meetings if requested.

As a first step in helping ANIC organize a program to reduce vandalism, Mr. and Mrs. Charlie Young were very much interested in holding a block meeting to further discuss this problem on the block-group level.

BLOCK REPRESENTATIVE APPOINTED FOR BLOCK #22

Mr. Herbert Lewis was appointed by ANIC's Executive Board as the Block Representative for Block #22 during March and his appointment had not been mentioned in ANIIC-DOPE until this time.

Mr. Lewis agreed to work with the neighbors in his block to assist Mrs. John E. Louis who has previously been Block Leader for both Block 21 and 22.




STREET SWEEPING





INFORMATION CENTER HAS NEW SIGN


A new sign was installed at the Information Center during the past month and the Portland Development Commission is very proud of the satisfied comments that people have made about it.

ANIC WELCOMES NEW SERVICE FOR ALBINA AREA


The Urban League of Portland has initiated a new and extended program in the Albina District. An additional person has been added to the staff who will serve as a field worker in the northeast area.



INFORMATION STAFF HOLDS TRAINING SESSION


The Portland Development Commission staff at the Information Center held a three-day training session with representatives of FHA and local banks on July 7, 8 and 9.

ALBINA IMPROVEMENT PROJECT RECEIVES FINAL APPROVAL

On August 19, 1964, the Portland City Council approved the assessment district for the Project area which was the last step in gaining Project approval. This approval followed by one day the Federal Government's announcement that all funds for the Project had been approved.


The gross project cost is \$2,178,491, and the approval specifically means that we will be able to:

1. Have the assistance of the Development Commission staff and the continued operation of the Information Center.
2. Begin repairs to curbs and sidewalks and paving of alleys.
3. Obtain the proposed park and traffic diverters.
4. Gain the assistance of City officials to identify and correct fire and health hazards.
5. Accept the cooperation of the Federal Housing Administration to work out home improvement loans for carrying out repairs to structures in the area.
6. Continue informational programs and educational activities to improve the livability of the area.

The picture above was taken at the public hearing in the City Council Chambers at City Hall. Rev. Rogers is shown addressing the Council and many others also attended and spoke in favor of the assessment district.

A group of persons also attended the hearing and presented a petition against the assessment district. The petition opposing the district represented 31.52% of the area.

Peace Corps Trainees from Portland State College, as part of their training program, worked with families in Block #36 in an alley clean up on July 27, 28, and 29.






STRUCTURE INSPECTIONS UNDERWAY IN PROJECT AREA

PLANNING COMMISSION TO TAKE ACTION ON IMPROVEMENT

PLAN ZONE CHANGE PROPOSAL

The zone change proposal along Vancouver Ave., which was incorporated into the Neighborhood Improvement Plan, will be presented to the zoning committee of the City Planning Commission for action on October 13, 1964.

The proposal (changing the present commercial zone on both sides of Vancouver Ave. from Shaver St. to Beech St. to residential zoning) was made a part of the Improvement Plan in order to stop any possible commercial development on the west side of Vancouver between Shaver and Beech and to afford protection to these properties by halting possible commercial development on the east side of the street.

A business group received, on October 5, 1964, a building permit to develop a self-service carwash and hamburger stand on the northeast corner of Shaver and Vancouver which is in the zone change area. Because the permit was applied for and issued prior to the zone change taking effect, such a use would be permissible.





TREE PROGRAM SUBCOMMITTEE MEETS





Shown below at one stage of construction is a picture of "The Americana," a new center which will feature 32 ultramodern Brunswick bowling lanes with automatic pinsetters, free nursery, billiard tables, modern restaurant, sport shop, meeting rooms, and off-street parking for 95 cars. This center is just one of the many new facilities planned for the Albina area. It will eventually be owned primarily by stockholders (at present there are 56) in the Greater Albina Development Corporation which is made up of local residents. The Americana is also being financed in part by a loan from the Small Business Administration which has a definite interest in upgrading this particular area.

The manager of The Americana is James C. Crolley who resides at 3806 N. Albina. Assisting him will be Jim Renfro who lives at 3718 N. E. 9th Avenue. The opening date will be announced in the near future.

PARK FINANCING DISCUSSED AT ANIC MEETING

At the November 5, 1964, neighborhood ANIC meeting at Boise School, the following question was raised: "Will each property owner be billed for his portion of the cost of developing the park?" Albina Neighborhood Improvement Committee's Executive Board felt this question should be clearly answered in ANIIC-DOPE.

The cost of financing the park development is not the responsibility of property owners. Money to develop the park has been included in the project budget. Specifically, the Portland Development Commission will acquire the properties, clear the land, and develop the park with the money which has been appropriated for this purpose. It must be made clear that property owners will not be required to contribute money for the park development.

1. Know the reputation of your contractor or dealer.
2. Be sure he is willing to put his promises down in writing.
3. Read a contract carefully and understand it before signing it; keep a copy.
4. Do not sign completion certificate before work is completed to your satisfaction.
5. See that all work conforms to local building codes and regulations.
6. Investigate bargain advertisement opportunities-- if you are in doubt, get expert advice.


He closed with the Better Business Bureau's motto:




Speaker on Heating Problems. Pictured below is Mr. Dick Dougherty, of the Dougherty Co., who spoke at the regular monthly meeting of the Albina Neighborhood Improvement Committee on December 3. Mr. Dougherty, a heating system installer, gave the following helpful hints regarding home heating:

1. A house will warm up faster if all vents are open.
2. Find a comfortable temperature for your home and leave the thermostat set at that point.
3. At night do not turn the thermostat down too much; it then takes extra long in the morning to bring the temperature back up to the desired level and thereby unnecessarily increases your heating cost.
4. You do not save fuel by installing a fan on a gravity furnace.
5. Regarding insulation: insulating the attic is the best bet for cutting fuel costs.



Economic Opportunity Act Meetings. As announced at the last general monthly meeting of the Albina Neighborhood Improvement Committee, meetings were held at Boise, Highland, and Eliot schools during the week of December 7 to 11 in an effort to explain the Economic Opportunity Act (sometimes referred to as the Anti-Poverty Act). These meetings covered such areas as housing, employment, job training, day care and neighborhood centers. An attempt was made at these sessions to define the needs of the Albina area and to propose solutions which would meet the standards of the Economic Opportunity Act. The attendance at the meetings showed that the people of the area are vitally interested in getting help to promote such programs as are needed. These meetings were sponsored by the Metropolitan Steering Committee and the Portland Community Council. A summary session was held on December 16, at which time certain areas of need were stressed such as a day nursery for the area, employment opportunities, and a neighborhood center. We will keep you posted as to the eventual projects. An important meeting regarding Economic Opportunity Act proposals for the Greater Albina area will be held on December 29. Please contact the Information Center for time and place.

Albina Art Center Proposed. An Art Center for the Albina area has been proposed by the Urban League of Portland under the auspices of its Field Office on North Williams Avenue. This Center would have as its purpose to provide training for talent in the area, a cultural and recreational outlet, and the development of the community's resources in this area. There will be showings and instruction in painting, sculpture, pottery, and photography. Also, four plays will be offered in 1965, and a program in music started.
