




#### BOWLING ALLEY CONSTRUCTION IN PROJECT AREA

Clearance of the property acquired by the Balch Land Development Corporation for construction of a bowling alley has been completed.

In November, the Balch Corporation requested a variance of restrictions approved by the City Council in 1961. The developers asked for a reduction of the setback on Albina Street from 15 feet to 5 feet; opening through the setback on Failing Street to permit a major entrance and exit to their parking lot; and a waiver for one of the two loading berths required by the ordinance.

Some property owners in the project area objected to the effect of such a facility on adjacent and nearby residential properties when the original zone change request was made. However, the

#### INFORMATION CENTER PROGRESS REPORT

Since the last regular ANIC meeting, the Information Center staff has been concentrating on completing a report of the project plans.

City Council granted the zone change with Buffer Zone restrictions which were expected to afford the maximum protection to the adjacent residential properties.

The variances must be granted to permit construction under present plans. However, at a meeting with the Director of the Planning Commission on December 27, Mr. Leiper, Brunswick Representative, suggested that further efforts would be made to meet the requirements originally approved by the City Council.

#### DEVELOPMENT COMMISSION ANNOUNCES PROMOTION OF STAFF MEMBER

The Portland Development Commission announced on December 14, 1962, that Larry Coons had been promoted to the position of Assistant Director. Mr. Coons replaces Dick England who has accepted a job in Los Angeles, California.

All data, survey information and other material gathered by ANIC and the Information Center staff during the past year is being evaluated and incorporated into this report. The report will be submitted to the Federal Government for preliminary review to assure ANIC and property owners that the Federal Government will be willing to help pay for a part of the cost of the improvement project.





## FINAL PLANNING REPORT APPROVED FOR SUBMISSION



The Portland Development Commission gave approval on January 31, 1963, for submission of the final planning report to the Federal Government to see whether the Urban Renewal Administration will help finance the proposed plan.

Approval for submission of the report is an indication that the Commission is interested in participating in the proposed plans for the Albina Neighborhood Improvement Project. However, the following steps will still be necessary to gain final approval of the project after word is received that the Federal Government will participate:

- a.) Property owners must approve an assessment district to help pay the cost of some improvements such as alleys.
- b.) The plan must be officially reviewed by the members of the City Planning Commission.
- c.) The plan must be approved by the City Council.
- d.) The project must be approved by the Administrator of the Housing and Home Finance Agency.

While the report is being reviewed by the Federal Government, the Information Center staff will continue to provide assistance in the area and to help complete the programs that were initiated during the Survey and Planning Stage.

DEVELOPMENT COMMISSION ANNOUNCES  
PROMOTION OF STAFF MEMBER

The Portland Development Commission announced on January 21, 1963, that Tom Notos had been promoted to Community Services Coordinator. He replaces Larry Coons.

HOUSING AUTHORITY'S APPLICATION FOR  
DEMONSTRATION HOUSING PROGRAM NOT  
APPROVED

The Portland Housing Authority's application for a scattered-sites demonstration housing program to be developed in conjunction with the Albina Neighborhood Improvement Project did not receive approval of the Housing and Home Finance Agency.

The demonstration proposal called for construction of fifteen single-family structures on vacant land within the Project Area. This program was to be coordinated so that its objectives would meet the objectives of the Albina Neighborhood Improvement Project.

AGREEMENT REACHED ON BOWLING ALLEY  
CONSTRUCTION PLANS

Through action taken by concerned property owners in the Project Area, the Balch Land Development Corporation has agreed to meet the requirements originally approved by the City Council for construction of a bowling alley.

The present plans for construction are similar to the original plans which provided for; entrance and exit to the parking area from Mississippi Avenue, a 15 foot setback from Albina Avenue, building facing Mississippi, and no

pedestrian access from or to Albina Avenue.

CITY PLANNING COMMISSION REPORTS ON  
CENTRAL ALBINA STUDY AT ANIC MEETING

Mr. Lloyd Keefe and Mr. Frank Frost, Director and City Planner of the City Planning Commission, reported that a study concerning the future development of Central Albina had been made. The study area lies between Fremont and Broadway Streets and Union and Interstate Avenues.

During this study traffic patterns were analyzed and structure condition, value and age recorded.

Through the study, Mr. Keefe said it was learned that: 1) There is no long-term market for residentially zoned property; 2) There could be a long-term market for non-residential land use; 3) The best probable types of non-residential uses would be light manufacturing, distribution, and service industries; 4) There would be some market for multi-family housing; 5) There is neither present nor future demand for retail business along Williams Avenue; 6) Eliot School is readily adaptable for many types of commercial and industrial use if the market demands and it is put up for sale.

In concluding their report, Mr. Keefe and Mr. Frost related that this area (Fremont, Broadway, Union and Interstate) will undoubtedly experience a rapid change after the freeway network has been completed.



PROPERTY OWNERS PARTICIPATING IN TREE  
REMOVAL, TRIMMING AND PLANTING ACTI-  
TIES IN DEMONSTRATION BLOCKS

Exciting and interesting progress is being made on North Kerby between Fremont and Failing Streets. The utility companies' tree crews have been trimming and removing large older trees, at no charge, which have damaged curbs and sidewalks and have reduced the efficiency of the street lights.

Property owners in these blocks readily gave their permission for the trimming and removal of these trees and they are ordering flowering trees (Kwanzan Cherry) which will be planted this month in accordance with ANIC's adopted Tree Program Plan.

Wood from the removals was made available to property owners at fireplace length.

The Tree Program Subcommittee recommended that the initial activities begin in a two block demonstration area because the spring planting season is nearly at an end.

Upon completion of the activities in the demonstration blocks all remaining property owners in the project area will be contacted so that they may have the opportunity to give their authorization for removal of other large trees which

are detrimental to curbs, sidewalks, and efficient street lighting. When these contacts are made, property owners may also select the type of trees they want planted in the Fall.

Complete assistance and cooperation of Project Area residents will assure completion of the Tree Program activities and installation of the new street lights by the Fall.

Property owners in the demonstration blocks and the members of the Tree Program Subcommittee deserve a great deal of credit for the time and work they have contributed in launching the Tree Program Plan which will beautify the area.


A representative of School District #1 will explain the proposed school tax levy at the April 4th ANIC meeting. This proposed levy will be on the April 26th special election ballot.

#### PROPOSED TAX LEVY DISCUSSED WITH ANIC

Dr. William Oliver, Assistant Superintendent, Portland Public Schools, was a guest at the last meeting.

The Committee invited Dr. Oliver to the meeting to explain the proposed school tax levies. This special school election will take place on April 26.

This levy, he said, is a two-fold proposal. Included on the ballot will be a building levy and an operating levy. Dr. Oliver said, "the levies are not really new taxes, they will continue building on school programs previously approved by Portlanders".

The proposed building levy is to replace the 1952 approved levy which has expired. The two-year operating levy will extend the one approved in March 1961 which expires in June this year.

He explained that if these levies are defeated by the voters, the school district will have to cut back on many of its student programs and maintenance of buildings.



Prime subject of discussion at this meeting was the development of good parent-child relations.



### MR. E. H. THIEL AND REV. ROOSEVELT ROGERS ELECTED ANIC COCHAIRMAN

The Albina Neighborhood Improvement Committee received a Nominating Committee report from the Chairman, Reverend Roosevelt Rogers at their regular meeting on June 6, 1963.

Rev. Rogers reported that he, Mrs. Mamie Bowles, Mrs. Joseph C. Crane, and Mr. Frank Brown finalized nominations for the chairmanship of ANIC at their May 22 meeting. The Nominating Committee recommended to ANIC:

1. Amending the Bylaws and creating an Executive Board whose members will conduct the business of ANIC and coordinate Committee activities.
2. The Executive Board will meet at least once per month prior to the regular Committee meetings.
3. Appointment of the immediate past Cochairmen and future past Cochairmen to the Executive Board to serve in an advisory capacity.
4. Appointment of Mr. E. H. Thiel and Rev. Roosevelt Rogers to the Board as Cochairmen.
5. Appointment of Mrs. Joseph C. Crane to the Board as a member-at-large.
6. Reappointment of Tom Notos to serve as Secretary of the Albina Neighborhood Improvement Committee.

After considerable explanation and discussion, unanimous approval was given to the Nominating Committee's recommendation by the members of ANIC.

TREE PROGRAM PROGRESS IN PROJECT AREA

At the last regular Albina Neighborhood Improvement Committee meeting, Rev. F. J. Crear, Tree Program Subcommittee Chairman, reported that three block-area meetings have been held for those residents on Commercial, Kerby, Borthwick and Albina. At present, permission has been obtained to trim or remove 53 trees and property owners on these streets have purchased 36 new trees.

NEW HOUSING PROJECT PLANNED FOR ALBINA DISTRICT

The Housing Authority of Portland received City Council approval of a zone change permitting them to construct a 135 unit low-rent housing project in the Albina district.

The designated area lies between Fremont, Mississippi, Cook and the Minnesota Freeway. The zone change that was approved was one which changed the existing A-2.5 zone to an A-1 zone. The portion of the area zone M-3 remained the same.



## PROPERTY OWNERS HOLD BLOCK CLEAN UP

Families living in Block #33 (Kerby, Commercial, Beech and Fremont) had their Block Clean Up activity on Saturday, July 13.

Children thirty-three strong, outfitted with hoes, pitchforks, pruning shears, shovels, saws, and brooms, began the clean up work on July 9. This "work force" cut weeds, stacked limbs, and collected cans and bottles so that the removal of the debris could be done quickly.

John Deines, Business Representative of the Sanitary Truck Drivers Local 220, visited the block with Mrs. Evelyn Harriman, Neighborhood Advisor. The alley, he said, has not been usable by trucks since 1950. Mr. Deines carefully outlined the steps to follow for easy removal of debris during a clean up campaign:

1. Cut back all overhanging tree limbs that will scratch cars and trucks and stack separately.
2. Cut or saw all branches for easy handling.
3. Pull loose, fallen limbs, berry vines embedded in dirt, and stack in piles by side of alley.
4. Prune all vines and shrubbery back to property lines.

5. Separate tin cans, bottles, broken glass, metal newspapers, and garbage into boxes and place on edge of property.

The families in Block #33 who participated in the clean up activities have planned to hold a picnic at Blue Lake Park on Saturday, July 20, 1963. The day's outing will include swimming, picnicing and other outdoor activities. One block resident said that "we should always try to combine work with pleasure."

Reverend Roosevelt Rogers, ANIC Co-chairman, is helping with picnic arrangements.

#### RAPID PROGRESS BEING MADE ON TREE PLAN

The latest progress report of the Tree Program Plan shows that:

1. Property owners have purchased 100 new trees.
2. Property owners have requested that 118 large trees be removed.
3. Property owners requested that 33 trees be trimmed.

All property owners, except those on Kerby and Borthwick who have been undecided regarding removal or trimming of their trees may still contact the Information Center (AT 2-2214) for this free service.

Mr. & Mrs. Albert Williams of 3905 N. Kerby said, "We are delighted that we had the opportunity to remove the four large trees in our parking strip and replace them with the much more attractive Kwanzan Cherry."

Mrs. Martha Payne, Mrs. Mamie Bowles, Mrs. Ernestine Broadous, Rev. Roosevelt

Rogers, and Mr. E. H. Thiel met at the Information Center on Thursday, June 27, to discuss ways of involving more people in the Tree Program.

Mrs. Payne and Mrs. Bowles offered to contact all the families in their block regarding tree orders. They urged all property owners who were interested in helping the Committee obtain tree orders to call at the Information Center. All orders and payment for the new trees, they said, must be received by September.

#### EXECUTIVE BOARD MEETS

A special meeting of the Executive Board was called Friday, June 21, 1963, at ANIIC. Rev. Roosevelt Rogers, Mr. E. H. Thiel, Cochairmen of ANIC, and Father Mell Stead, met to discuss and clarify the Portland Housing Authority's proposal for 135 new dwelling units to be located west of Mississippi and south of Fremont.

It was explained that this proposal is to take the place of the 58-unit Daisy Williams Project. This new site is one of five the Planning Commission recommended for possible public housing use.

The Board members reviewed a letter addressed to ANIC advising of a public hearing to be held concerning the proposed housing project. The Board agreed that there was insufficient time to make an objective study of the proposal. Therefore, Rev. Rogers moved that a letter be sent to the Housing Authority informing them that ANIC would not make a recommendation due to the lack of time and information provided. The motion was seconded and approved.



### PORTLAND DEVELOPMENT COMMISSION HOLDS MEETING AT ANIIC

The members of the Portland Development Commission, Mr. Ira Keller, Chairman, Mr. A. V. Fonder, Mr. Vincent Raschio, Mr. Harold Halvorsen and Mr. Russell Colwell, held their August 12th meeting at the Information Center.

The Commission authorized Vincent Raschio to work with the staff to prepare plans and specifications so that improvements to the Information Center could be undertaken.

A report was given by the Information Center staff regarding the status of the final project report, the progress of the tree program and other citizens activities. It was explained that all report questions raised by the Federal Government have been answered and regional approval of the report is expected soon.

Other items of business covered by the Commission were related to the South Auditorium Urban Renewal Project, the study of the extension of the South Auditorium Project and the feasibility of filing an application for a General Neighborhood Renewal Plan for the Central Albina area south of Fremont Street.



### FIRST REGULAR ANIC NEIGHBORHOOD MEETING OF YEAR HELD

The regular neighborhood meetings began again on September 5th with the new members of the Executive Board, Mr. E. H. Thiel and Mrs. Joseph Crane, presiding.

Mrs. Crane reported that the Federal Government review of the Final Project Report has been completed by all departments except Financing. We understand, she said, that the Financing Department is presently making their review and we expect to receive word concerning regional approval of the Report very soon.

A discussion was held, due to the complaints of many families, concerning the problem of damage to shrubs, flowers and private property by dogs in the area. The Chairman was asked, since the Improvement Project focuses primarily on improvement and upkeep of private property, to investigate ways that ANIC might assist property owners in solving this problem.

It was learned that the City does have an ordinance which aims at controlling this problem. Under the provisions of this ordinance, owners of dogs are not permitted to let them run-at-large.

### NEWLY ELECTED BLOCK CHAIRMEN INTRODUCED AT ANIC MEETING

Mr. & Mrs. Charles Young, Cochairmen of Block #33, were introduced at ANIC's neighborhood meeting on September 5.

The Young's were elected at a Block Meeting held at the home of Mrs. Bobbie Smith on August 22.

The Committee is proud to welcome the new Block Chairmen as active Committee members and encourages all blocks to organize and elect a Block Chairman so that residents are adequately represented on the neighborhood committee.

### BOISE SCHOOL HAS NEW PRINCIPAL

Mr. Willard Fletcher began his new duties as Principal of Boise on September 9. He also becomes a member of ANIC, representing Boise School. Mr. Fletcher replaces Mr. Frank Brown who was transferred to Jason Lee School.

Mr. Brown requested that, due to his new duties, he be placed on ANIC's inactive Committee member list.

### BEAUTIFICATION SUBCOMMITTEE FORMED

Father Mell Stead, Mrs. Maggie Young, Mr. Robert Kutch, and Mrs. Lucille Dick, were appointed members of ANIC's newly created Beautification Subcommittee.

Father Stead explained that the purpose of this Subcommittee is to develop plans for conducting a contest involving home improvements and landscaping.

The Subcommittee members will meet at the Information Center to work out final arrangements for this contest and further information concerning this topic will be covered in later issues of ANIIC-DOPE.

### BLOCK 28 HOLDS BLOCK MEETING

Residents of Block 28 held a Block Meeting on Thursday, September 12, at the Information Center.

Mr. Willie Whitley, ANIC member, organized the meeting of residents in his block so that they could begin their alley clean up activities.

The preliminary estimate indicated that a fee of \$1.60 per resident would be charged to remove the debris.

FINAL PLANS FOR CLEAN UP OF ALLEYS BEGIN

The Executive Board of ANIC met on August 14th with Mr. John Deines, Business Representative of Local 220 - Sanitary Truck Drivers' Union, and finalized a plan for clean up of alleys in the entire Project Area.

Mr. Deines stated that a fee of \$10.00 per load would be charged if residents would collect, pile, and help load the debris on the truck. Under normal circumstances, he said, the fee is \$30.00. Local 220 is absorbing the difference in cost as a public service to the people in the Project Area.

The following five blocks were surveyed by Mr. Deines to determine the amount of debris to be hauled away:

- Block 27 - Commercial, Haight, Failing, Beech
- Block 28 - Kerby, Commercial, Failing, Beech
- Block 29 - Borthwick, Kerby, Failing, Beech
- Block 32 - Borthwick, Kerby, Fremont, Beech
- Block 34 - Commercial, Haight, Fremont, Beech

Mrs. Harriman, Neighborhood Advisor, will be calling on residents of these blocks immediately so that clean up activities can begin as soon as possible.



### COLLECTION FOR TREE ORDERS PROGRESSING





### FINAL PROJECT REPORT APPROVED BY FEDERAL GOVERNMENT



#### ANIIC EXECUTIVE BOARD DISCUSSES PROJECT APPROVAL

The Final Planning Report for the Albina Neighborhood Improvement Project was approved by the Federal Government's Housing and Home Finance Agency on November 15, 1963. This approval means that the Federal Government will participate in the financing of the Project and enables the Albina Neighborhood Improvement Committee and the Portland Development Commission to proceed with obtaining needed local approvals of the Urban Renewal Plan for the Improvement Project Area.

The Executive Board of ANIC reviewed the letter at their November 27th meeting and discussed the pertinent facts about the Project which include:

## BASIC STEPS TO BE COMPLETED

The Executive Board reviewed the importance of the method for locally financing the Project. As a means to determine whether property owners will accept responsibility for financing the improvements to streets, curbs, sidewalks, and alleys, the members drafted a letter to the Portland Development Commission requesting Commissioner Bowes to have individual estimates under an Assessment District prepared.

Under such a proposal the estimates would be prepared by the offices of the City Engineer and City Auditor. The estimates would then be furnished to each property owner so that everyone will have the opportunity to discuss and ask questions about the individual assessments prior to a City Council public hearing on the Assessment District.

The members of the Executive Board discussed the necessary steps which must be taken in order to obtain local approvals of the Project. Details of the proposed Assessment District were outlined and the following steps were agreed upon as the procedure to follow prior to the City Council public hearing on the Improvement Project Plan.

1. A letter from ANIC to the Development Commission, requesting that an Assessment District be initiated, would be presented at the Commission's December 3rd meeting.
2. A letter would be sent to each property owner informing them that the individual estimates are being prepared.
3. A General ANIC Neighborhood Meeting would be held in January to discuss the proposed Assessment District.
4. The individual estimates would be mailed to each property owner.
5. Area Block Meetings will be held to enable property owners to discuss their individual assessment estimates.
6. A General ANIC Neighborhood Meeting will be held after the Block Meetings are completed to further discuss the attitude of residents and owners.
7. The Urban Renewal Plan and the Assessment District would be presented to the Portland Development Commission for approval.
8. The Urban Renewal Plan and the Assessment District would be presented to the City Planning Commission.
9. City Council Public Hearing would be set for the Assessment District and the Urban Renewal Plan.

## DEVELOPMENT COMMISSION ACTS

Commissioners Keller, Fonder, Raschio, Colwell, and Halvorsen reviewed the approval of the ANIP Planning Report and a letter received from ANIC at their meeting of December 3rd. A Resolution was approved and has been submitted to Commissioner Bowes and members of the City Council requesting that action be taken to provide individual cost estimates for alley, sidewalk, curb, and street improvements in the Albina Neighborhood Improvement Project.
