An Ordinance authorizing the release of any interest of the City of Portland of certain sewer rights in the lot line common to Lots 23 and 24, and the lot line common to Lots 24 and 25, Block 8, Kings Heights, to Calvin E. Gantenbein and Jean Brown Gantenbein, husband and wife, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that by deed recorded October 1, 1945, in P.S. Deed Book 972, at Page 293, the City of Portland conveyed Lots 22, 23, 24 and 25, Block 8, Kings Heights to Calvin E.
