

ORDINANCE No. 188606

Revise ordinance to correct the fee schedules for tree permits (Ordinance; amend Ordinance No. 188415)

The City of Portland Ordains:


Section 1. The Council finds:

1. Ordinance No. 188415 passed Council on May 31, 2017 amending the fee schedules for tree permits.
2. Portland Parks and Recreation staff presented testimony requesting the fee schedules for tree permits be updated with an effective date of July 1, 2017.
3. City Council indicated support for the ordinance in their discussion during the May 31, 2017 hearing and subsequently the motion was made and passed through Council vote.
4. The ordinance passed, but included errors in Exhibit A: Proposed Trees Fee Schedule FY 17-18.
5. The corrections are detailed in Exhibit B of this ordinance.

NOW, THEREFORE, the Council directs:


- a. Exhibit A of Ordinance No. 188415 of the Council directive is replaced with Exhibit A of this ordinance.
