Portland City Code Title 3.30.030 specifies that members of the Development Review Advisory Committee (DRAC) may serve up to two 3-year terms. Current DRAC member Claire Carder has completed a first term, is eligible for reappointment, and has expressed interest in continuing to serve on the DRAC. In addition, after a thorough review process, I am recommending three candidates for appointment to vacant DRAC positions for 3-year terms running from October 11, 2017 through October 10, 2020.

Martha Williamson is a Senior Associate/Senior Project Manager at Humber Design Group, Inc. with 18 years of experience focused mostly on the private development of urban sites. Martha has expertise in stormwater management and public works permits assocated with urban infill projects. Martha works regularly with City staff from several bureaus on public works permits and is very familiar with City development review services and processes. Martha is a licensed Professional Engineer in Oregon.

These three candidates would bring a wealth of expertise and experience to the DRAC. I recommend that Alex, Sarah, and Martha be appointed to 3-year terms on the DRAC. Their appointments will help ensure that the good work of the DRAC continues on behalf of BDS and other City bureaus, the development industry, and the community.

With these appointments, one vacant position (Small Businesses) would remain on the DRAC. We are currently actively recruiting candidates for that position. I have enclosed an updated DRAC membership list reflecting these new appointments.
