PROPERTY DESCRIPTION:

Subject is an 80'x108' lot approximately 5 feet above the street grade, all public utilities connected. The yard is not very well cared for. House is vacant and there are numerous shade and fruit trees and other shrubs.

Improvements consist of a 1-story and attic frame dwelling built in 1905 with 1180 sq.ft. on the main floor and 900 sq.ft. in the basement. There is a covered wood porch area.

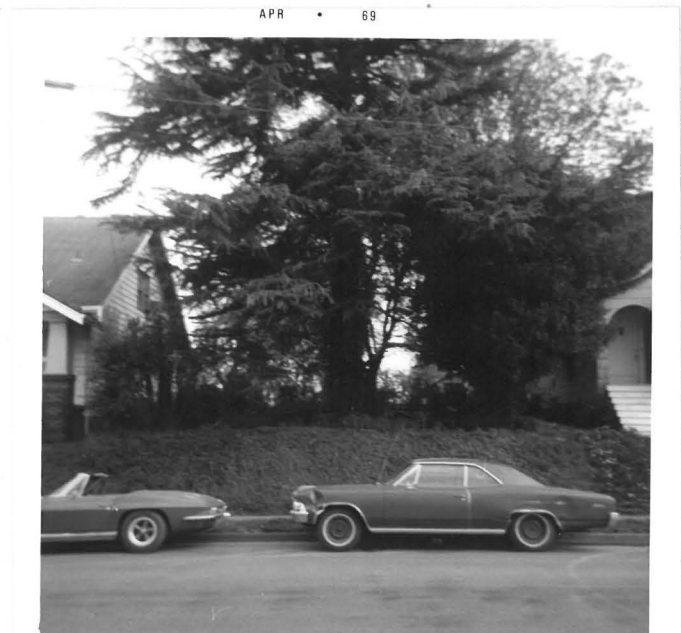
Interior consists of an entry hall, living room, dining room with glass doors leading to the living room, 2 bedrooms, kitchen with built-in china closet and cabinet below, combination metal sink and drain with built-in storage cabinet with wood counter, hard fuel range; a utility room with four trays, new 30-gallon gas hot water heater. Another small room has a built-in refrigerator, There is an enclosed rear porch with a toilet room.

Second floor has 3 bedrooms, average size; a bathroom with old toilet and basin and rim tub.

Exterior is finished with asbestos shake siding, composition roof in fair condition, gutters and downspouts in fair condition. There is a shed in the rear yard which is about 400 sq.ft. which is used for storage and does not have much value.

Property is in poor condition, mechanically and electrically. There is considerable deferred maintenance.
