*Authorize grant agreement with a selected service provider to support increasing capacity building for street level gang outreach program that provides gang intervention services while principally deployed for service within Bureau of Parks and Recreation facilities and properties, in an amount not to exceed \$207,684 for calendar years 2018 and 2019 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- The City, through the Office of Youth Violence Prevention (OYVP), facilitates the Street Level Gang Outreach program established in 2009. The program is modeled after a nationally recognized best practice acknowledged by the Office of Justice Programs, U.S. Department of Juice, and Bureau of Justice Assistance.
- 2. Portland Parks & Recreation (PP&R) currently provides grant funding to support the work of Portland Opportunities Industrialization Center, Inc., in its street level gang outreach work under grant agreement no. 30004949. The grant funds in that agreement allows POIC to increase its program capacity and create opportunities to deploy two full time gang outreach workers to engage youth and young adults at Parks facilities and events from December 2015 through December 2018.
- 3. PP&R has additional available grant funds for calendar years 2018 and 2019. PP&R intends to issue a public solicitation to seek interest from qualified nonprofit corporations that are engaged in street level gang outreach services and that may desire grant support capacity building in the area of youth and young adult violence intervention and prevention, particularly in services to certain vulnerable community populations affected by higher level of gang violence. Information on the grant solicitation generally is attached hereto as Exhibit A.
- 4. Following the competitive grant process, PP&R will enter into a grant agreement that will provide grant funding to the successful grant application in an amount of not more than \$103,842 for each calendar year commencing January 1, 2018 to December 31, 2019 which would be for a total grant award of not-to-exceed amount of \$207,684.

NOW THEREFORE, the Council directs:

a. Upon conclusion of the solicitation and selection of qualified application, the Director of Portland Parks & Recreation is authorized to enter into a Grant Agreement with the selected service provider, in a form to be prepared in conformance with this Ordinance and the grant solicitation information, using the grant agreement template attached hereto as Exhibit B, and pursuant to approved as to form by the City Attorney's Office.

- b. The Director of Portland Parks and Recreation is authorized to execute further amendments to the scope of services or the terms and conditions of the grant agreement, and is authorized to execute subsequent amendments that increases grant funding when the approved City Budget includes such appropriations.
- c. The Mayor and the Auditor are hereby authorized to pay for the contract from the FY 2017-18 Budget, Account 529000, Center Code 9PKPR00045.

Section 2. The Council declares that an emergency exists because a delay in funding would hinder gang outreach services from being utilized during events. Therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
