ORDINANCE No. 188807

*Pay settlement of the grievance of Jon Bates in the sum of \$50,000 involving the Bureau of Transportation (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Portland Bureau of Transportation (PBOT) terminated employee Jon Bates on or about February 22, 2017. The District Council of Trade Unions, IBEW Local 48 ("DCTU/IBEW") grieved the termination. The City denied the grievance and DCTU/IBEW advanced the grievance to arbitration.
- 2. The parties now desire to compromise and settle the grievance.
- 3. As part of the proposed settlement, the City shall pay Jon Bates an amount of \$50,000.00.
- 4. The City and DCTU/IBEW shall equally split the arbitrator's cancellation fee.
- 5. DCTU/IBEW withdraws the grievance with prejudice.
- 6. PBOT and the City Attorney's Office recommend acceptance of the proposed settlement.
- 7. Per PCC 3.15.050, the Director of the Bureau of Human Resources has reviewed and approved the proposed settlement.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$50,000 made payable to "Jon Bates".
- b. PBOT will execute a payment authorization in the amount set forth in subparagraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this claim; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
