Ernestina Fuenmayor is both a trained architect and historian with a degree in Architecture from the Central University of Venezuela, Certificate in Historic Preservation from Boston Architectural College, and a Masters in Historic Preservation from the University of Oregon. She has appeared before the Historic Landmarks Commission as an applicant and presenter and has extensive experience in documenting historic places within Oregon and abroad. Ernestina has several years of volunteer experience including serving on the Board of DoCoMoMo Oregon and advocacy through the Portland Coalition for Historic Resources. Originally from Venezuela, Ernestina will bring a global perspective to the issues we face locally as we attempt to preserve our heritage while also accommodating growth.

Ernestina believes in collaborative approaches to development that involve listening to both applicants and the community prior to decision-making. She has also stated that she intends to provide a sense of inclusion to the community through her role on the Commission and to help educate the public about what history means and brings to the community. Her diverse

professional and volunteer experience would be a real asset to the Historic Landmarks Commission.
