TO THE COUNCIL:

On December 20, 2017, Council approved Ordinance Number 188744 for Procurement Services to competitively solicit the Price Agreements for routine construction services at Columbia Boulevard Wastewater Treatment Plant, Tryon Creek Wastewater Treatment Plant, and associated pump stations in accordance with PCC 5.34. The Chief Procurement Officer has advertised and received bids for Bid Number 00000806 on behalf of the Bureau of Environmental Services (BES), with a project construction estimate of \$6,000,000. BES rated the project estimate confidence level as Optimal.

Bids were opened on February 13, 2018, and two (2) bids were received. The bids from Titan Utilities, LLC and Iron Horse Excavation, LLC DBA Oxbow Construction were responsive to the solicitation requirements, thus it is recommended that the Titan Utilities, LLC and Iron Horse Excavation, LLC DBA Oxbow Construction bids be accepted for an annual amount of \$1,500,000.00 each for a period of two years.

These are Price Agreements which do not have defined Scopes of Work, the Scopes will be developed and agreed upon by individual Task Order. For each Task Order, Titan Utilities, LLC and Iron Horse Excavation, LLC DBA Oxbow Construction acting as the prime contractors will identify areas for subcontracting opportunities. The City identified in the solicitation and contracting documents an aspirational goal for D/M/W/ESB subcontractor and supplier utilization at 20% of the hard construction costs. Outreach will be performed for each task order to ensure compliance with the goal.

Titan Utilities, LLC is located in Beaverton, Oregon and Iron Horse Excavation, LLC DBA Oxbow Construction is located in Troutdale, Oregon, and both are State of Oregon Certified D/M/W/ESB Contractors. They have a current City of Portland Business Tax Registrations and are in Full Compliance with the City's contracting requirements.

Funds are available for these projects in BES's Sewer System Operating Fund, FY 2017/18 and 2018/19 Budgets.

It is recommended that a Performance Bond and Payment Bond each at 100% of the individual task order amount be furnished by the Contractor. Further, it is also recommended that a two (2) year Maintenance/Warranty Bond for 20% of the final task order amount be furnished by the Contractor before final payment on the task order is released.



