Legislation title: Rename streets west of the Willamette River and east of SW Naito Pkwy, SW View Point Terr and Tryon Creek State Natural Area from Southwest to South, creating a sixth addressing sextant in the City of Portland and Multnomah County; and rename SW Aventine Circus, SW Esquiline Circus, SW Front Ave and portions of SW Military Rd (Ordinance; amend Ordinance No. 61325; amend Code Chapter 24.75.10)

Purpose of proposed legislation and background information:

This Ordinance will eliminate leading zero addressing in the portion of Southwest Portland east of SW Naito Parkway, bringing these addresses in compliance with postal addressing standards. This will in turn eliminate the need to train emergency response personnel on this nonconventional addressing protocol, thereby shortening training time for emergency response personnel. This change will improve customer service by eliminating the need to manually verify leading zero addresses with 9-1-1 callers, thereby shortening 9-1-1 call times and potentially reducing 9-1-1 callers' wait times during peak times. It will also eliminate ongoing costs of programming information technology "workarounds" to support nonstandard leading zero addressing.

This Ordinance also will bring Portland's addressing sectors into compliance with addressing standards by using streets and landmarks to more clearly and intuitively designate the boundary between South and Southwest Portland, in addition to clarifying the boundary between North and Northeast Portland in a short 4-block segment in the Rose Quarter area, with no existing occupied buildings in the Rose Quarter affected by this change.

During the outreach process, PBOT received inquiries from property owners about wayfinding issues, primarily in the Collins View Neighborhood Association and in the Riverdale neighborhood of unincorporated Multnomah County, outside the Portland City limits, for which the City of Portland provides land use, planning and other services on behalf of Multnomah County under an existing intergovernmental agreement. Some street names are being changed aside from changing Southwest to South, and some addresses are being changed other than removing the leading zero in response to these concerns and to improve wayfinding and emergency response.

PBOT engaged extensively with the City of Hillsboro prior to and during Portland's outreach process to apply their expertise from a major street renaming in Hillsboro to Portland's much smaller effort. Hillsboro's manager of this effort, Dan Dias, will join City staff in the presentation to Council and will be available to answer Council questions.

Financial and budgetary impacts:

- The cost of this project is estimated at \$305,000 for which a General Fund request has been submitted for the FY18-19 budget year.
- The level of confidence is Low.
- No change to staffing levels.
- 64% of the General Fund revenue (\$196,000) is to be added to the FY18-19 fiscal year budget.
- 36% of the General Fund revenue (\$109,000) is to be added to the FY19-20 fiscal year budget.
- The project is not currently in the 5-year CIP and is not on the current Transportation System Development Charge (TSDC) list of projects.

Community impacts and community involvement:

PBOT has received complaints about leading zero addressing during the South Portal Project, which Council approved in December 2016 and from which the South Portland Addressing Project was developed into a new and separate project.

Community and interbureau outreach and engagement:

- 1. The Bureau of Fire & Rescue, the Multnomah County Sheriff's Office, and the Lake Oswego Fire Department all provide emergency response to the current leading zero addressing area and were briefed on August 15, 2017.
- 2. The Multnomah County Chair's Office was briefed on September 29, 2017.
- 3. Lewis & Clark College was briefed on the proposed addressing changes on October 3, 2017 and again on April 10, 2018.
- 4. Oregon Health & Sciences University was briefed on the proposed addressing changes on November 17, 2017.
- 5. The Homestead Neighborhood Association has a very small area within the current leading zero addressing area, and was briefed on December 2, 2017.
- 6. The Planning & Sustainability Commission was initially briefed on December 12, 2017.

- 7. The South Burlingame Neighborhood Association and Portland Downtown Neighborhood Association were briefed separately on December 15, 2017.
- 8. The Collins View Neighborhood Association whose area is nearly entirely within the current leading zero addressing area, was briefed on December 27, 2017.
- 9. The South Portland Neighborhood Association whose area nearly entirely within the current leading zero addressing area, and was briefed on January 3, 2018.
- 10. The Portland Police Bureau provides emergency response to the current leading zero address area and was briefed on January 3, 2018.
- Multnomah County Commissioner Sharon Meieran, whose district includes the future 11. South Portland Addressing area, was briefed on January 10, 2018.
- 12. The Southwest Neighborhoods Inc. Transportation Committee was briefed on March 19, 2018.
- 13. Notification of street name changes were mailed to affected property owners in the City of Portland and unincorporated Multnomah County on February 15, 2018, and invited property owners to attend any of four (4) public open houses. It also provided the dates, times, locations and manner in which to testify to the Planning & Sustainability Commission and to the City Council, as well as contact information for the South Portland Addressing Project Manager.
- 14. A small mailing was sent on March 2, 2018, advising of a planned South Portland addressing boundary change. Notices were sent to owners of property between SW Palatine Hill Road on the east and north, SW 1st Avenue on the west, and SW Ridge Drive on the south, after consultation with Portland Fire & Rescue and board members of the Collins View Neighborhood Association.
- 15. The first public open house was held on March 8, 2018 at the Mirabella Auditorium in South Waterfront.
- The Planning & Sustainability Commission held a public hearing on March 13, 2018. 16.
- The second public open house was held on March 15, 2018 at Riverdale Grade School. 17.
- 18. The third open house was held on March 22, 2018 at the Mirabella Auditorium in South Waterfront.
- 19. The fourth open house was held on April 4, 2018 at Riverdale High School in Collins View.
- The Planning & Sustainability Commission held a public hearing on March 13, 2018. 20.

- 21. Clackamas County Planning, whose jurisdiction includes streets adjacent to the South Portland Addressing area, was briefed on April 24, 2018.
- 22. The Portland Bureau of Emergency Management and the Bureau of Emergency Communications were briefed on May 23, 2018.

MEMORANDUM TO COUNCIL

Rename streets west of the Willamette River and east of SW Naito Pkwy, SW View Point Terr and Tryon Creek State Natural Area from Southwest to South, creating a sixth addressing sextant in the City of Portland and Multnomah County; and rename Aventine Circus, SW Esquiline Circus, SW Front Ave, SW Northgate Ct and SW South Ridge Dr (Second Reading Agenda 574; introduced by Mayor Wheeler and Commissioner Saltzman; amend Ordinance No. 61325; amend Code Chapter 24.75.010)

I. ADDRESS CHANGES

Addresses currently being reviewed by the Bureau of Development Services for address changes <u>after</u> Council adoption of this Ordinance include:

- The request of the owner of the property currently addressed as 7 SW Collins Street to evaluate whether 7 SW Collins Street can appropriately be retained as the address number; and
- The suggestion of the owner of the property currently addressed as 11020 SW Esquiline Circus to change the address to 11060 S. Esquiline Avenue instead of the address of 11064 S. Esquiline Avenue contained in Exhibit C of this Ordinance; and
- Further evaluation of SW Tryon Hill Road and SW Tyron [sic] Hill Road addresses for possible address number changes, including resolving the current 3-digit and 5-digit address numbers currently assigned to properties on this street.

The decisions of Bureau of Development Services (BDS) and/or the Bureau of Fire & Rescue (PF&R) on these and any other subsequent address changes requested by property owners will <u>not</u> be reflected in Exhibit F of this Ordinance, but will be updated on the South Portland Addressing Project website and <u>www.sixthsextant.com</u> in addition to mail notification of the property owner.



However, the website will not necessarily reflect new addresses created (which result from new development) after the Council filing of this Ordinance.

All South Portland Addressing project address changes including those made subsequent to Council adoption of this Ordinance, will be made in May 2020 or the earliest practicable date thereafter per Directive 'e' of this Ordinance unless BDS and/or PF&R determine under their administrative authority that an earlier address change is necessary for public safety.

II. ORDINANCE TITLE

The above Ordinance title was developed in close consultation with the Auditor's Office with the objective of not increasing the length of the Ordinance title beyond its current 78 words.

The streets whose names were included in the Ordinance title were included for the following reasons:

- SW Aventine Circus and SW Esquiline Circus were included in the Ordinance title because the current street suffix of "Circus" does not meet current U.S. Postal Service addressing standards. This criterion was not applicable to any of the other streets being renamed within the body of this Ordinance.
- SW Front Avenue was included in the Ordinance title because of the policy decision as to whether to rename it to SW Naito Parkway or to SW View Point Terrace, and this street segment was referenced on slide #8 of the Council PowerPoint. Exhibit C directs that SW View Point Terrace be the new street name.
- SW Northgate Court was included in the Ordinance title because of the preponderance of property owner complaints about wayfinding difficulties for properties addressed from this current street name.
- SW South Ridge Drive was included in the Ordinance title because of the inconsistency of properties on the street currently being alternately addressed as SW South Ridge Drive and SW Southridge Drive; all will change to a uniform S. Southridge Dr.

The streets whose names were not included in the Ordinance title were excluded for the following reasons:

- Street names whose underlying street names are unchanged, with only the directional changing from Southwest to South, were not included in the Ordinance title.
- SW Palatine Street changing to S. Northgate Avenue was not included because the legally platted street name is SW Palatine Street, and in effect two street names are changing to S. Northgate Avenue.
- The five (5) street segments in the Rose Quarter area were not included in the Ordinance title. No addresses of currently-occupied Rose Quarter buildings are proposed to be changed in bringing these streets' names into compliance with Code Chapter 24.75.010 previously adopted by Council on June 1, 1989 with the adoption of Ordinance No. 161894. It was felt that it would be particularly confusing to include a renaming of NE Interstate Avenue in the Ordinance title, and that a reader of the Ordinance title could easily fail to distinguish the directional of "NE" from North when reading the Ordinance title.

PROPOSED AMENDMENTS TO THE SOUTH PORTLAND ADDRESSING ORDINANCE

Rename streets west of the Willamette River and east of SW Naito Pkwy, SW View Point Terr and Tryon Creek State Natural Area from Southwest to South, creating a sixth addressing sextant in the City of Portland and Multnomah County; and rename SW Aventine Circus, SW Esquiline Circus, SW Front Ave, SW Northgate Ct and SW South Ridge Dr (Ordinance; amend Ordinance No. 61325; amend Code Chapter 24.75.010)

I. SUMMARY

The Bureau of Development Services completed assignment of new address numbers on May 25, 2018, necessitating amendments to Exhibits C and F the South Portland Addressing Ordinance. Scrivener's corrections to Finding Nos. 3 and 11, and Directives 'c', 'e' and 'k' of the Ordinance and Exhibit H are also being made.

Exhibit 'G' includes a de minimus cost estimate to rename SW Fairview Circus and NW Luray Circus; however, neither street will be renamed by the Ordinances to be considered by Council per Agenda Item Nos. 574 and 575 on May 31, 2018. Renaming of these streets was deferred due to the potential need for the Bureau of Development Services to assign new address numbers.



II. DETAIL OF PROPOSED AMENDMENTS

The South Portland Project Manager therefore requests that Council approve the following amendments:

- 1. The date reference in Finding No. 3 is changed from January 13, 1892 to January 6, 1892.
- 2. The reference to nine (9) addresses in Finding No. 9 is changed to eleven (11) addresses.
- 3. The reference in Directive 'c' is changed from Exhibit C to Exhibit H.
- 4. The reference in Directive 'e' is changed from Exhibit C to Exhibit F.
- The reference in Directive 'k' is changed from Exhibit B to Exhibit C.
- 6. Rows 157 through 159 of Exhibit C with the current street name of SW Esquiline Circus are changed to S. Esquiline Avenue.
- 7. A new Row 487 is created in Exhibit C changing existing SW Palatine Street from SW Palatine Hill Road to S. Northgate Avenue. This change is applicable to the segment from the renamed S. Palatine Hill Road. to the renamed S. Northgate Avenue.
- 8. Existing Rows 487 through 694 of Exhibit C are renumbered as Rows 488 through 695.
- 9. Row 54 of Exhibit F for the property currently addressed as 11415 S. Aventine Circus is changed to 11415 S. Aventine Avenue.
- 10. Row 57 of Exhibit F for the property currently addressed as 11505 S. Aventine Circus is changed to 11505 S. Aventine Avenue.
- 11. Row 94 of Exhibit F for the property currently addressed as 3838 S. Barbur Blvd. is changed to 3838 S. Barbur Blvd.
- 12. Rows 112 and 1051 of Exhibit F are deleted and existing Rows 112 through 1050 are renumbered as Rows 111 through 1049, and existing Rows 1052 through 9601 are renumbered as Rows 1050 through 9599.

- 13. Current Rows 2309 through 2319 of Exhibit F (which will be renumbered to Rows 2307 through 2317 per Item No. 12 above) for the properties currently addressed on SW Esquiline Circus are changed to S. Esquiline Avenue with no change to the proposed new address numbers in Exhibit F.
- 14. Current Row 5835 of Exhibit F (which will be renumbered to Row 5833 per Item No. 12 above) for the property currently addressed as 11611 SW Military Road is changed to 1240 S. Military Road.
- 15. Current Row 6672 of Exhibit F (which will be renumbered to Row 6670 per Item No. 12 above) for the property currently addressed as 0910 SW Palatine Hill Road is changed to 11328 S. Northgate Avenue.
- Current Row 6673 of Exhibit F (which will be renumbered to Row 6671 per Item No. 12 above) for the property currently addressed as 0920 SW Palatine Hill Road. is changed to 11255 S. Northgate Avenue.
- 17. Current Row 6677 of Exhibit F (which will be renumbered to Row 6675 per Item No. 12 above) for the property currently addressed as 0926 SW Palatine Hill Road. is changed to 11285 S. Northgate Avenue.
- Current Row 6678 of Exhibit F (which will be renumbered to Row 6676 per Item No. 12 above) for the property currently addressed as 0930 SW Palatine Hill Road. is changed to 11250 S. Northgate Avenue.
- 19. Current Row 8504 of Exhibit F (which will be renumbered to Row 8502 per Item No. 12 above) for the property with an owner address of 230 SW Riverdale Road. is changed to 1840 S. Riverdale Road.
- 20. Current Rows 9174 and 9175 of Exhibit F (which will be renumbered to Rows 9172 and 9173 per Item No. 12 above) for the property with addresses of 12134 SW Tryon Hill Road and 12134 SW Tyron Hill Road [sic] is changed to TBD by BDS.
- Current Row 9176 of Exhibit F (which will be renumbered to Row 9174 per Item No. 12 above) for the property with an address of 12148 SW Tryon Hill Road is changed to TBD by BDS.
- 22. Current Row 9177 of Exhibit F (which will be renumbered to Row 9175 per Item No. 12 above) for the property with an address of 12156 SW Tryon Hill Road is changed to TBD by BDS.



MapID Current Site Address






