Good afternoon Mayor Wheeler and Commissioners,

My name is Felisa Hagins and I am the Political Director for the Service Employees International Union, Local 49. SEIU Local 49 is an over 13,000-member union comprised of healthcare and property service workers, most of whom live in the metro area. Our mission as a union is to improve the quality of life for our members, their families, and dependents by achieving a higher standard of living by elevating their social conditions and by striving to create a more just society.

On behalf of our members, I am writing to voice support for the proposed City budget. Of particular importance to our members is the fact that this budget maintains and protects good union jobs *outside* of the City's direct employment.
