Jeffrey Cordial – Jeffrey has spent the last 9 years of his career learning the ins and outs of sustainable building, technology, and green energy production. Jeffrey has been heavily involved in the Solar and Green Energy Industry in Portland, through his role as Pac Northwest District Manager for CED Greentech, and as a business member of both the US Green Building Council and the Oregon Solar Energy Industry Association.
