#### Purpose of proposed legislation and background information:

This Resolution updates the PCCEP Plan previously adopted by Council as described in the Resolution. It refines the PCCEP Plan based on the work of the Mayor's staff, the PCCEP Project Manager, the Selection Advisory Committee and the Facilitators, working with the community

#### Financial and budgetary impacts:

No fiscal or budgetary impacts.

#### Community impacts and community involvement:

The City has engaged in a lengthy process to involve the community in the formation of the new PCCEP. Two citizen advisory committees have been constituted to advise on the selection of the facilitator and on the selection of members. From May to September 2017, Council held five hearings on the proposed amendments to the Settlement Agreement, eventually approving the PCCEP Plan. The Mayor has been holding monthly forums on policing to involve and inform the community in these issues until the new PCCEP is up and running, including a forum on August 29 dedicated to the PCCEP itself. The facilitators have been reaching out to the community particularly to populations not traditionally involved in City processes. One purpose of these amendments is to give a voice to youth on the PCCEP as to how the police should engage with the community. The City has also consulted extensively with the Albina Ministerial Alliance Coalition for Justice and Police Reform on these amendments

# Wheeler Amendments to PCCEP Plan

## Wheeler Amendment 1

Under Members' Responsibilities, add "On a quarterly basis" to the following sentence: *Gather input from Portlanders regarding experiences with and perceptions of PPB's community outreach.* 

The amended sentence will read: *On a quarterly basis*, gather input from Portlanders regarding experiences with and perceptions of PPB's community outreach.

Wheeler Amendment 2 and 3

Replace all references throughout to the Office of Neighborhood Involvement (ONI) with the Office of Community and Civic Life (Civic Life).

- Amendment 2: General consultation with the Office of Community and Civic Life (Civic Life) and/or District Coalitions, Coalition of Communities of Color, and Civic Life's Diverse Civic Leadership partners
- Amendment 3: The PCCEP shall meet at least twice per year with the Chief, the Police Commissioner, PPB Precinct Commanders, PPB Neighborhood Response Teams, and a representative of the Office of Community and Civic Life Crime Prevention to assess and solicit comment on PPB's activities in regards to community outreach, engagement, and problem-solving policing.
