

An Ordinance to vacate all that part of Russett Street in the City of Portland, Multnomah County, Oregon, lying between the east line of Emerald Street and the west line of Drummond Street in said city.

WHEREAS, due notice was given by advertisement thereof for four successive weeks, to wit: from February 24th, 1914, to March 24, 1914, both dates inclusive, in the official newspaper of the City of Portland, Oregon, to wit: the "Portland Daily Abstract", published in the said city, that at a regular meeting of the Council of said city to be held on Wednesday March 25th, 1914, at the hour of 10 o'clock A. M., a petition would be presented to said Council praying for the vacation of all that part of Russett Street in the City of Portland, Multnomah County, Oregon, lying between the east line of Emerald Street and the west line of Drummond Street in said city, which said notice and due proof of its publication was filed in the office of the Auditor of said city on the 24th day of March, 1914, and which petition referred to in said notice was filed in the office of the Auditor of said city on the 21st day of March, 1914, and both said notice and petition are now on file in said office; and,

WHEREAS, said petition praying for the vacation of said portion of said street was duly presented to said Council on Wednesday the 25th day of March, 1914, and said petition duly set forth a description of that part of Russett Street to be vacated, and the reasons for such vacation, and was duly signed by School District No. 1 of Multnomah County, Oregon, by R. L. Sabin, Chairman, and also set forth the purpose for which the ground was proposed to be used, and to which said petition there is appended, as a part thereof, and as the basis for such vacation, and as the basis for the granting of the prayer of said petition, the consent of the owners in fee simple of

more than two-thirds of the real estate fronting on both sides of said portion of said street, which is proposed to be vacated, estimated upon the frontage of that portion of the street sought to be vacated, such frontage commencing at a line drawn equidistant from the termini of the portion of said street sought to be vacated and extending along such portion the entire length thereof and two hundred feet in each direction from the termini thereof, which said consent of said owners is in writing and duly acknowledged before an officer authorized to take acknowledgments and is attached to said petition, and together with said petition filed with the Auditor of said City of Portland, Oregon; and,

WHEREAS, the Council did on presentation of said petition, together with the consent of the requisite number of owners and proof of publication on said 25th day of March, 1914, fix Friday the third day of April, 1914, at the hour of 10 o'clock A. M. as the time for hearing said petition and all objections that may be filed thereto; and,

WHEREAS, said Council has ascertained and determined, after fully hearing said petition at the time fixed therefor, and did and does ascertain and determine and cause it to be made a matter of record that all of the foregoing recited facts and things have been done and that the consent of the owners in fee simple of more than two-thirds of the real estate fronting on both sides of said portion of said street proposed to be vacated, estimated upon the frontage of that portion of said street sought to be vacated, such frontage commencing at a line drawn equidistant from the termini of that portion of said street sought to be vacated, and extending along such portion the entire length thereof and two hundred feet in each direction from the termini thereof, has been obtained in the manner as



required by the Charter of said City, and that the public interests will not be prejudiced by the vacation of said portion of Russet Street sought to be vacated, and the said Council at the time fixed for the hearing and now so finding; and,

WHEREAS, no objections have been made or filed to the granting of said petition, and it appearing that no reasons exist why the same should not be granted in whole, and it further appearing that all of the proceedings in the matter of the proposed vacation of said portion of said Russett Street have been legally and regularly conducted in accordance with the Charter of said City, and that said petition should be granted and the vacation of said portion of said Russet Street be made a matter of record; now, therefore,

The City of Portland does ordain as follows:

Section 1. That all that part of Russet Street in the City of Portland, Multnomah County, Oregon, lying between the east line of Emerald street and the west line of Drummond street in said City, be and the same is hereby vacated, and that said vacation be and the same is hereby made a matter of record.
