An Ordinance--Entitled:


An ordinance licensing the "Oaks Amusement Co" a corporation, to conduct, operate and maintain a place of amusement known as "The Oaks" in the City of Portland, Multnomah County, Oregon.

Be it enacted by the City of Portland:

Section 1, That there be and is hereby granted, to "The Oaks Amusement Co" a private corporation, a license to conduct, operate and maintain a place of amusement known as "The Oaks" in the City of Portland, Oregon, on the O.W.P & Ry Co's property, on the east bank of the Willamette River, near the southern limits of the City of Portland, until further direction and order of the Council of the City of Portland.

Section 2- That the said "The Oaks Amusement Co" pay to the City of Portland, the sum of \$300.00 quarterly, in advance for said license, which sum shall be in full payment of all amusements, and entertainments operated and conducted in and about the premises described in Section 1.
