

ORDINANCE NO. 189547

Authorize two-year grant agreements with seven youth-serving organizations in support of the Teen Collaborative Initiative not to exceed \$560,000 and per grant not to exceed \$80,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Beginning in 2015, as part of an overall expansion of investment in Teen Programs, Portland Parks & Recreation (PP&R) was authorized to support youth-serving organizations by providing grant funding so these organizations can serve our community's at-risk youth and provide positive social activities for at-risk youth in safe and supportive environments.
2. Ordinance 187884, passed July 6, 2016, authorized a prior set of grant agreements that supported programming for at-risk youth in partnership with PP&R. Ordinance 188969 passed May 30, 2019, authorized extension of those grant agreements and provided PP&R the opportunity to improve the overall process of soliciting and awarding grants and to improve access to grant funding opportunity and transparency.
3. On February 24, 2019, PP&R conducted a Request for Grant/Funding to solicit Partner Participation Applications for the Teens Collaborative Initiative grant funds.
4. After reviewing applications and proposals submitted in response to the solicitation, PP&R determined these seven youth-serving organizations can provide the services required:
 - Native American Youth and Family Center (NAYA)
 - Latino Network
 - Immigrant & Refugee Community Organization (IRCO)
 - Self Enhancement, Inc. (SEI)
 - Portland Opportunities Industrialization Center (POIC)
 - New Avenues for Youth DBA: SMYRC
 - Elevate Oregon
5. The seven organizations will provide culturally responsive programming to at-risk youth during out of school time. These organizations will employ engagement strategies that allow for youth to develop more positive interactions and will provide activities that support leadership and skill development as well as academic support.

6. For Fiscal Year 2019-2020, the aggregate amount of grant funding that will be allocated the seven organizations will not exceed \$280,000 in the aggregate, with each organizational grant not to exceed \$40,000. The specific aggregate grant funding amount is being sought in the FY 2019-2020 budget process.
7. For Fiscal Year 2020-2021, the potential aggregate amount of grant funding that may be allocated to the seven organizations will not exceed \$280,000 in the aggregate, with each organization grant not to exceed \$40,000. The availability of grant funds for Fiscal Year 2020-2021 will be determined during the later budget process. The organizations have been informed that continuation of any grant agreement into the second year and the grant funding that may be available would be subject to future City Council decisions.

NOW, THEREFORE, the Council directs:

- a. The Director of Portland Parks & Recreation is authorized to execute the attached grant agreements, in the forms substantially similar Exhibit A, as approved to form by the City Attorney, with:
 - i. Portland Opportunities Industrialization Center (POIC);
 - ii. Immigrant & Refugee Community Organization (IRCO) – Africa House;
 - iii. Latino Network;
 - iv. Native American Youth and Family Center (NAYA);
 - v. Elevate Oregon;
 - vi. New Avenues for Youth; and
 - vii. Self-Enhancement, Inc. (SEI).
- b. The Director, or designee, is authorized to take all actions on behalf of the City, including executing amendments of grant terms and covenants, provided contract changes do not increase the legal or financial risks to the City, and amendments are approved as to form by the City Attorney. Any increase to grant funding must be approved by the City Council.
- c. The Director and City Auditor are hereby authorized to pay the grant amounts stated in the agreements to the extent such funds have been allocated in PP&R's Fiscal Year 2019-2020 and/or 2020-2021 budgets.



