Suit now pending; property virtually vacated.

85-7 North Second Street:

Property of the notorious Louise Olcese. Under bond
for \$25,000. This case was the first case tried and

Under temporary injunction and contempt proceedings
now pending for violation of the injunction. All
women gone from the place.

330 Flanders Street:

Suit filed and pending.

328 Flanders Street:

Suit pending; property vacant.

334 Flanders Street:

Suit pending.

272-1/4 Burnside Street:

Property vacated on threat of suit and building now
torn down and replaced by business block.

308 Couch Street:

Property of Dr. Andrew C. Smith. Suit filed and
place now in hands of reputable people.

310 Couch Street:

Property of Dr. Andrew C. Smith. Suit filed and place now in hands of reputable people.

34-1/2 Broadway:

Suit pending.

326-1/2 Couch Street:

Suit pending; supplemental complaint filed March 30, 1914.

328 Couch Street:

Suit pending.

325-1/2 Couch and 33-1/2 North Sixth St.:

Suit and supplemental complaint pending.

41 North 5th Street:

Owned by Earl of Darnly. Vacated by women on threat of suit and now occupied by male Greeks.

307 Couch Street:

Cleaned up under threat of abatement suit.

315 Couch Street:

Conditions modified by threat of suit, but still under observation.

340 Ankeny Street:

Suit filed; property now used as cleaning and tailoring establishment.

66-1/2 North Fourth Street:

Torn down.

305-1/2 Burnside Street:

Hart Hotel; under bond of \$500.

71 Sixth Street:

The Comox, a popular parlor house. Suit filed and bond now in preparation.

9-11-13-15 North Eleventh Street:

Formerly occupied as four prosperous parlor houses. All vacated as result of suit against Beatrice St. Clair. Property now believed to be in respectable hands.

426 Everett Street:

Suit filed and bond prepared.

343 Flanders Street:

A negro resort. Suit filed and now pending on merits.

189 Clay Street:

Suit and bond filed. Bond in ~~some~~ \$400.

210 Davis Street and
48-52 North First St.:

Quarter block of cribs now under bonds and vacated by women.

188 Clay Street:

Kept by notorious Rosie Babcock. Suit filed and case now pending on demurrer of defendant.

109 North Park Street:

A small negro place under bond of \$100.

123-1/2 Fourteenth Street:

Parlor house, formerly kept by Elsie Douglas. Suit filed.

90-1/2 Fifth Street:

Hotel Astor. Daisy Gordon ousted by owners on representation by this office, but place again under observation.

66-3/4 Sixth Street:

Oxford Hotel. Raided in November by sheriff at instance of district attorney's office. Proprietors, Harris & Parker, indicted for keeping bawdy house. Place vacated by them and now believed to be in reputable hands.

248 Ash Street:

Hotel Levens. Suit filed January 29, 1914 and continued indefinitely upon promise to oust tenant, Hulda Levens.

228 Main Street:

Owned by College Endowment Association. Arrangements pending for bond.

82-1/2 North Third Street:

Suit pending. Defendants have indicated purpose of giving bond.

147 Eleventh Street:

Two flourishing parlor houses. Suit filed April 6, 1914.

16 Twelfth Street:

Bradford Hotel. Suit filed and tenant Lillian M. Davis ousted by proprietors.

228 Couch Street:

Suit pending. Place vacant.

421-27 Alder Street:

Majestic Hotel, owned by Mrs. P. J. Mann. Bond filed.

110 North 9th Street:

Suit pending.

267 Taylor Street:

Gilbert Hotel closed by owners September 1913, upon filing suit, and vacant since that date.

11 Twelfth Street:

Alma Hotel. Suit filed.
