Legislation title: Amend Intergovernmental Agreement with Home Forward to extended term through September 30th, 2022 to continue to provide patrol services at the New Columbia housing sites. (Ordinance; amend Contract No. 30002975)

Purpose of proposed legislation and background information:

The New Columbia Community Policing Team emphasizes a community policing approach toward law enforcement, public safety, and community livability. The team is the collaborative effort of Portland Police Bureau, Home Forward, New Columbia property management, the Portland Office of Community & Civic Life, and Portland Public Schools.

Home Forward, formerly the Housing Authority of Portland, coordinated the New Columbia Community Policing Team, and entered into an intergovernmental agreement with the City of Portland's Police Bureau (PPB) in 2012. The City provides 4 full-time police officers to the Team.

The City has amended this intergovernmental agreement three times since its inception in 2012. The first amendment occurred in April, 2014, reducing the remuneration received by PPB by \$30,000 annually.

The second amendment to this agreement occurred in August, 2015, extending the agreement out to September 2017 with no further changes in terms.

The third amendment to the intergovernmental agreement between Home Forward and the City of Portland for New Columbia patrol services was dated in September 2017; this amendment extended the validity of the agreement to September 30, 2019 without changing any other terms or conditions.

PPB continues to provide officer patrol services to the New Columbia housing sites in exchange for expense reimbursement from Home Forward, and would like the City to extend this agreement to September 30, 2022 by allowing a fourth amendment.

Financial and budgetary impacts:

None, this program is to be funded through an ongoing appropriation for this purpose in the Police Bureau budget.

Community impacts and community involvement:

PPB provides a seven day-a-week community policing presence at New Columbia; this includes participating in community events, meetings, youth leadership events, and other building activities.

The agreement emphasizes referral for appropriate treatments or to social services, as opposed to more traditional law enforcement measures, in order to provide New Columbia households assistance with drug, alcohol and domestic issues. A key component of the agreement is for PPB to make every effort to have the officers assigned to the Team be seen as approachable and accessible to the residents of New Columbia.
