

Ordinance No. 189714

*Amend the effective date of Ordinance No. 189580 to allow Portland Housing Bureau to adopt administrative rules prior to the March 1, 2020 implementation date and make technical clarifications to 30.01.086 (Ordinance; amend Ordinance No. 189580)

The City of Portland ordains:

Section 1. The Portland City Council finds:

1. On June 19, 2019 the City Council adopted Ordinance No. 189580 to further fair housing law and address the effects of discrimination on housing access throughout the City.
2. The Ordinance contained new code, section 30.01.086, with an effective date of March 1, 2020.
3. The City Council delegated rulemaking authority to Portland Housing Bureau (PHB) to implement the Ordinance, with an effective date of March 1, 2020.
4. The City Council wishes to authorize PHB to begin rulemaking prior to the March 1, 2020, effective date of code section 30.01.086.
5. PHB has engaged with community and industry stakeholders in advance of rulemaking for the purpose of identifying technical clarifications needed in 30.01.086.

NOW THEREFORE, the Council directs:

- a. Section 1, directive b, of Ordinance No. 189580 is amended to state:

PHB is hereby directed to promulgate administrative rules that will 1) carry out the provisions of Exhibit A, section 30.01.086; 2) create forms, materials, and trainings related to the implementation of this Ordinance; and 3) establish a delayed implementation plan.

- b. Section 1 of Ordinance No. 189580 is amended to make directives a and e effective on March 1, 2020.
- c. Section 1 of Ordinance No. 189580 is amended to make directives b, c, and d effective immediately upon Council adoption of this Ordinance.

d. Section 1, directive e, of Ordinance No. 189580 is amended to state:


The Portland Housing Bureau shall report to City Council on the progress and implementation of this policy, including recommendations for any changes that may be needed, within one year of the March 1, 2020, implementation date, of Portland City Code Section 30.01.086.

e. Section 30.01.086 is amended as provided in Exhibit A.

Section 2. The Council declares that an emergency exists because delay of PHB's delegation of rulemaking authority could also delay implementation of the new Portland City Code Section 30.01.086 beyond the intended March 1, 2020, date; therefore, this ordinance shall be in full force and effect from and after its passage by the council.
