

## West Side Public Safety Action Coalition (*W-PSAC*)

Good morning.

My name is Steve Trujillo and I'm here today to introduce the West Side Public Safety Action Coalition. We refer to ourselves as PSAC.

As concern about public safety has increased across the City of Portland, a diverse group of stakeholders representing the west side of the city, has come together to explore collaborative ways of improving safety and livability for everyone across Multnomah County.

PSAC is a registered Oregon non-profit organization with an established board, officers, and standing committees. The mission of *PSAC* is to be a voice for the community and to interact with residents government, nonprofits and local businesses in support of programs to reduce crime and create a safe, clean and welcoming Portland.

Our goals include the following:

To achieve increased funding for jail beds to reduce the "revolving door" that puts repeat, often violent offenders immediately back on the street. We aim to ensure offender accountability and access to justice for victims.

To promote clear guidance and direction for law enforcement to enforce ordinances and laws deemed a community priority.

And to support effective efforts to establish a compassionate avenue to manage the rising drug epidemic and establish and support more effective after care and wrap around services for those accessing drug treatment.

These are multi-faceted challenges and we hope to build partnerships with other organizations to coordinate efforts to manage public safety concerns. We also intend to focus on data and research to inform and support best practices for effecting sustainable change.

PSAC represents neighborhoods and other communities working together to advance agency and dignity for all. We hope to serve as a model for the entire county to make things safer, more vibrant and more comfortable for everyone.
