GRANT AGREEMENT WITH CONSTRUCTING HOPE PRE-APPRENTICESHIP PROGRAM

This Grant Agreement is between the CITY OF PORTLAND, OREGON ("CITY" or "GRANTOR") and Constructing Hope Pre-Apprenticeship Program ("CONSTRUCTING HOPE" or "GRANTEE") in an amount not to exceed \$100,000 for FY 2019-2020 to provide 10-week construction skills and life skills training classes and comprehensive support to move unemployed and underemployed Portlanders into careers with middle-class wages in the skilled construction trades.

RECITALS:

- The Cannabis Social Equity Grant is an Office of Community & Civic Life ("CIVIC LIFE") program that is a restorative justice and community reinvestment grant opportunity funded by the City of Portland's 3% local tax on retail cannabis sales. The Cannabis Program in the Office of Community & Civic Life will award eight to ten-month (8 to 10month) grants to promote small businesses, especially women-owned and minority-owned businesses and provide economic opportunity and education to communities disproportionately impacted by cannabis prohibition. Priority funding areas for the 2019 Cannabis Social Equity Grants are: Record-clearing and Expungement, Workforce Development, and Re-entry Housing.
- CIVIC LIFE selected applications through a competitive process. CIVIC LIFE received 32 applications for this funding cycle. The Review Panel, consisting of six community members and one City staff, represented areas of expertise or community-based knowledge in alignment with the goals and priority funding areas for the grant. Five panelists were selected and appointed by Commissioners, one panelist was a member of the City's cannabis program advisory body- the Cannabis Policy Oversight Team (CPOT), and the final panelist was City staff from the Portland Housing Bureau. First, panelists completed an independent scoring process. The Review Panel then met for a 6-hour facilitated in-person meeting, to collaboratively score and discuss final recommendations. Applications were reviewed solely on the information presented in the application. The Review Panel scoring meeting concluded with a recommendation that the City fund six projects/programs for a total of \$631,321. Program staff met with Bureau Director, and the staff representing the Bureau's Commissioner-in-charge to discuss the panel's recommendations. Director Rhee and Commissioner Eudaly's office has recommended that the panel's final selection be funded in alignment with the panel's

recommendation.

- 3. CONSTRUCTING HOPE submitted a grant application for the FY 2019-2020 Cannabis Social Equity Grant Program and was selected as one of the six organizations recommended to be awarded a grant to its "Building Equity: Construction Skills Training, Expungement and Job Placement" program.
- 4. In accordance with the FY 2019-2020 Budget, the CITY now desires to make a grant award to GRANTEE in an amount not to exceed \$100,000.
- 5. CONSTRUCTING HOPE, founded in 2010, is a non-profit organization dedicated to rebuilding lives and encouraging self-sufficiency through skills training and education in the construction industry. CONSTRUCTING HOPE's goals are to help the long-term unemployed attain sustainable careers, increase workforce diversity, reduce recidivism, and meet hiring needs in the construction industry. They help families move from poverty into the middle class through construction and life skills training, as well as through connections for child care and family support.
- 6. CONSTRUCTING HOPE will provide no-cost, ten-week, construction skills and life skills pre-apprenticeship training programs to minorities, people coming from incarceration and low-income adults. CONSTRUCTING HOPE will provide case management. transportation support, driver's license assistance, tools, work boots, personal protective equipment, and support with attaining key certifications. Participants will be connected with construction temporary employment industries to provide "survival jobs" for students needing immediate employment while they are in the program. CONSTRUCTING HOPE will help participants navigate the expungement process, drivers license assistance, and database input and reporting. Graduates will be placed in paid construction apprenticeships, pathway jobs leading to apprenticeship, and other career paths. Mentorship programs build connections for graduates with successful tradespeople of color. CONSTRUCTING HOPE will make a three-year commitment to each graduate for placement, retention, and advancement services.
- 7. GRANTEE's mission is consistent with the Council's desire for equity and inclusion, healthier people, and a safer city.

THEREFORE, in consideration of the mutual promises and covenants contained herein, the parties agree as follows:

ARTICLE I – SCOPE OF WORK/OUTCOME MEASURES

GRANTEE agrees to implement the work as described in ATTACHMENT A (Scope of Work), ATTACHMENT B (Budget), which is incorporated by reference.

- GRANTEE shall maintain record of general organizational and administrative information, documents, papers, taxes, time records and evidence of payment for program wages, salaries, and benefits, and GRANTEE services that are related to this Agreement or GRANTEE's performance of work or services for the purposes of reporting on:
 - How funds were used to meet the agreed upon scope of work or outcome measures, and
 - Specific impact of Cannabis Social Equity Grant funds on GRANTEE programs and services.

ARTICLE II – AGREEMENT PERIOD

This Agreement shall become effective on the date of last signature and will terminate on June 30, 2020 unless extended in conformance with Article V, Section G or terminated in conformance with Article V, Sections A-E. Expenses incurred starting October 1, 2019 are eligible expenses for the grant funds reimbursement.

ARTICLE III – OVERALL GOALS

CIVIC LIFE mission is to promote a culture of civic engagement by connecting and supporting all Portlanders working together and with government to build inclusive, safe, and livable neighborhoods and communities.

This Agreement seeks to meet CIVIC LIFE long-term goals:

- 1. INCLUSIVE STRUCTURES Modeling the inclusive practices and processes we seek to promote, we will partner with diverse, self-identifying communities to:
 - Champion institutional practices for inclusion and transformational change within government structures;
 - Increase community building and civic engagement opportunities for communities working toward equitable outcomes for all Portlanders.
- 2. ADAPTIVE GOVENANCE To realize more adaptive decision-making in community and government, we will:

- Support inclusive cross-cultural, cross-issue organizing in community to reflect the ability of resilient communities to address complex, interconnected issues
- Lead internal capacity development within City government, particularly as it pertains to engaging communities toward equitable outcomes
- Create and hold shared space where community and government join together to identify opportunities and address shared challenges
- Support communities in pursuing forms of governance that reflect their lived experience, values, and aspirations.
- 3. FULFILLED AND EMPOWERED PORTLANDERS A progressive change in culture of civic engagement is foundational to long-term systemic community building and government change. We will:
 - Prioritize resources that support communities in building resilience both with and without their government,
 - Practice equitable sharing of resources,
 - Promote inclusive education, art, and play,
 - Create an environment for respectful dialogue and problem solving that acknowledges our differences as we work toward shared goals.

ARTICLE IV – SPECIFIC CONDITIONS OF THE GRANT

A. <u>Publicity</u>. CIVIC LIFE requires public acknowledgement for the projects and programs it supports, as outlined in the terms and conditions of your award. Unless otherwise advised in writing, an acknowledgment of CIVIC LIFE support must appear on all materials publicizing or resulting from award activities in the form of a Policy Statement. CIVIC LIFE Logo and credit line should also be used in acknowledging its support whenever possible.

An acknowledgement must be included in any materials resulting from or related to grant award, such as articles, reports, advertisements, databases, web resources, events, fliers, other written documents, or publicity. The prominence of the acknowledgement should be in direct relationship to the level of funding provided for the project relative to other sources of funding. Where possible, CIVIC LIFE support will be mentioned in newspaper articles, radio interviews, and other media activities to extent related to GRANTEE's work.

1. Logo: Current logo, with correct spacing, color or black and white shall be requested directly from CIVIC LIFE communications staff or assigned program staff.

- 2. Policy Statement: The acknowledgement of CIVIC LIFE support must also include the following statement: "Any views, findings, conclusions, or recommendations expressed in this [describe the publication: article, book, exhibition, film, program, database, report, web resource, etc.] do not necessarily represent those of the City of Portland." The policy statement requirement will be waived in instances when it is not feasible or appropriate to include it, such as on building plaques.
- 3. Credit Lines: A portion of the funding for the program/project comes from CIVIC LIFE: "The [title of this project/program/web resource/database etc.] has been made possible in part by a grant from the City of Portland, Office of Community & Civic Life."

All funding for the program/project comes from CIVIC LIFE: "The [title of this project/program] has been made possible through funding entirely by the City of Portland, Office of Community & Civic Life."

- B. <u>Records</u>. GRANTEE shall maintain all books, general organizational and administrative information, documents, papers, and records of GRANTEE that are related to this Agreement or GRANTEE's performance of work or services, for ten (10) years after CITY makes final grant payment, GRANTEE has made final report, or the termination date of this Agreement, whichever is later. GRANTEE shall provide CITY prompt access to these records upon request and permit copying as CITY may require.
- C. <u>CITY Grant Manager</u>. CITY hereby appoints Kimie Ueoka to act as its Project Manager with regard to this Agreement. CITY may, from time to time, designate another person to act as the City Project Manager and will inform GRANTEE in writing of any change in Project Manager.

D. <u>GRANTEE Project Manager</u>. GRANTEE hereby appoints Simon Collins to act as its Project Manager with regard to this Agreement. GRANTEE may, from time to time, designate another person to act as the GRANTEE Project Manager and will inform CITY in writing of any change in Project Manager.

- E. <u>Billings/Invoices/Payment</u>. The City Grant Manager is authorized to approve work, billings, and invoices submitted pursuant to this grant and to carry out all other CITY actions referred to herein in accordance with this Agreement.
- F. <u>Report</u>. GRANTEE will complete and submit to the City Grant Manager the following reports and documents:
 - 1. Partial Report: **Partial Reporting Form**, template included as ATTACHMENT C (Reporting Form), after the 15th day of January, 2020.
 - 2. Annual Report: signed **Annual Reporting Form**, template included as ATTACHMENT C, no later than thirty (30) days after 30th day of June, 2020.

ARTICLE V – PAYMENTS

- A. CITY will fund the work described in ATTACHMENT A in an amount not to exceed \$100,000 for FY 2019-2020. CITY may advance the GRANTEE a quarter of the grant value upon execution of this Grant Agreement and receipt of a request.
- B. GRANTEE will submit quarterly invoices using ATTACHMENT D (Invoice/Request for Payment Template) to the City Grant Manager for approval. The CITY will pay GRANTEE the amount of the invoice within thirty (30) days of the approval date. CITY's subsequent payments will be made after CITY review and approval of GRANTEE's periodic progress reports using ATTACHMENT C and ATTACHMENT D, which are due on a twice-annual basis from the date of the final agreement signature. GRANTEE may submit periodic progress reports and requests for reimbursement of approved expenses in advance of the due dates using ATTACHMENT C and ATTACHMENT D.
- C. If for any reason GRANTEE receives a grant payment under this Grant Agreement and does not use grant funds, provide required services, or take any actions required by the Grant Agreement, the CITY may terminate, reduce, or suspend any grant funds that have not been paid. In addition, CITY may require GRANTEE to immediately refund to the CITY any funds improperly expended or received by GRANTEE.
- D. Grant payments under this Agreement may be used only to provide the services or take the actions listed on ATTACHMENT A and expenses listed on ATTACHMENT B. Any changes to the approved budget must be authorized in writing by the City Grant Manager before any expenditure of funds in new amounts or line items.
- E. If GRANTEE's anticipated services or actions are terminated, discontinued, or interrupted, the CITY's payment of funds under this grant may be terminated, suspended, or reduced.
- F. GRANTEE shall keep vendor receipts and evidence of payment for materials and services. GRANTEE shall keep time records and evidence of payment for program wages, salaries, and benefits, and GRANTEE

services. GRANTEE shall make all receipts and evidence of payments promptly available to the Grant Manager, or other designated persons, upon request and during the CITY's annual monitoring process.

- G. <u>Prevailing wages</u>. State of Oregon, Bureau of Labor and Industries (BOLI) wage rates are required for certain contracts that total \$50,000 and above. If GRANTEE's project is subject to the prevailing wage requirements, GRANTEE will comply with the prevailing wage requirements of ORS 279C.800 through 279C.870 and any other applicable prevailing wage requirements contained in ORS 279C, Oregon administrative rules, or city code.
- H. <u>Prevailing wage indemnity</u>. GRANTEE AGREES TO INDEMNIFY, DEFEND, AND HOLD HARMLESS CITY, ITS EMPLOYEES, OFFICERS, AND AGENTS, FROM AND AGAINST ANY CLAIM, SUIT, OR ACTION, INCLUDING ADMINISTRATIVE ACTIONS, THAT ARISE OUT OF GRANTEE'S FAILURE TO COMPLY WITH ORS 279C.800 TO 279C.870 AND ANY APPLICABLE ADMINISTRATIVE RULES OR POLICIES.

ARTICLE VI – GENERAL GRANT PROVISIONS

- A. <u>Cause for Termination; Cure</u>. It shall be a material breach and cause for termination of this Agreement if GRANTEE uses grant funds outside of the scope of this Agreement, or if GRANTEE fails to comply with any other term or condition or to perform any obligations under this Agreement within thirty (30) days after written notice from CITY. If the breach is of such nature that it cannot be completely remedied within the thirty (30) days, notify CITY of GRANTEE's steps for cure and estimated time table for full correction and compliance, proceed with diligence and good faith to correct any failure or noncompliance, and obtain written consent from CITY for a reasonable extension of the cure period.
- B. <u>No Payment or Further Services Authorized During Cure Period</u>. During the cure period, CITY is under no obligation to continue providing additional grant funds notwithstanding any payment schedule indicated in this Agreement. GRANTEE shall not perform services or take actions that would require CITY to pay additional grant funds to GRANTEE. GRANTEE shall not spend unused grant funds and such unused funds shall be deemed held in trust for CITY. GRANTEE shall be solely responsible for any expenses associated with cure of its noncompliance or failure to perform.
- C. <u>Termination for Cause</u>. Termination for cause based on GRANTEE's misuse of grant funds shall be effective upon notice of termination. Termination for cause based on failure to comply or perform other obligations shall be effective at the end of the 30-day period unless a written extension of cure period is granted by CITY. GRANTEE shall return all grant funds that had not been expended as of the date of the termination notice. All finished or unfinished documents, data, studies, and reports prepared by GRANTEE under this Agreement shall, at the option of CITY, become the property of CITY; and GRANTEE may be entitled to

receive just and equitable compensation for any satisfactory work completed on such documents up until the time of notice of termination, in a sum not to exceed the grant funds already expended.

- D. <u>Penalty for Termination for Cause</u>. If this Agreement is terminated for cause, CITY, at its sole discretion, may seek repayment of any or all grant funds tendered under this Agreement, and decline to approve or award future grant funding requests to GRANTEE.
- E. <u>Termination by Agreement or for Convenience of City</u>. CITY and GRANTEE may terminate this Agreement at any time by mutual written agreement. Alternatively, CITY may, upon thirty (30) days written notice, terminate this agreement for any reason deemed appropriate in its sole discretion. If the Agreement is terminated as provided in this paragraph, GRANTEE shall return any grant funds that would have been used to provide services after the effective date of termination. Unless the Parties agree otherwise, GRANTEE shall finish any work and services covered by any grant funds already paid and shall not commence any new work or services that would require payment from any unused grant funds.
- F. <u>Changes in Anticipated Services</u>. If, for any reason, GRANTEE's anticipated services or actions are terminated, discontinued or interrupted, CITY's payment of grant funds may be terminated, suspended or reduced. GRANTEE shall immediately refund to CITY any unexpended grant funds received by GRANTEE.
- G. <u>Amendment</u>. The Grant Manager is authorized to execute amendments to the scope of the services or the terms and conditions of this Agreement, provided the changes do not increase CITY's financial risk. Increases to the grant amount must be approved by the City Council unless the City Council delegated authority to amend the grant amount in the ordinance authorizing this Agreement. Amendments to this Agreement, including any increase or decrease in the grant amount, must be in writing and executed by the authorized representatives of the Parties and approved to form by the City Attorney.
- H. <u>Non-discrimination; Civil Rights</u>. In carrying out activities under this Agreement, GRANTEE shall not discriminate against any employee or applicant for employment because of race, color, religion, sex, age, handicap, familial status, sexual orientation or national origin. GRANTEE shall take actions to insure that applicants for employment are employed, and that employees are treated during employment, without regard to their race, color, religion, sex, age, handicap, familial status, sexual orientation or national origin. Actions shall include but not be limited to, the following: employment, upgrading, demotion, or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship.

GRANTEE shall post in conspicuous places, available to employees and applicants for employment, notices, which state that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, or national origin. GRANTEE shall incorporate the foregoing requirements of this section in all of other agreements for work funded under this Agreement, except agreements governed by Section 104 of Executive Order 11246.

- I. <u>Audit</u>. CITY, either directly or through a designated representative, may conduct financial or performance audit of the billings and services under this Agreement or GRANTEE records at any time in the course of this Agreement and during the ten (10) year period established above in Article <u>III.B.</u> As applicable, audits will be conducted in accordance with generally accepted auditing standards as promulgated in *Government Auditing Standards* by the Comptroller General of the United States General Accounting Office. If an audit discloses that payments to GRANTEE exceeded the amount to which GRANTEE was entitled, then GRANTEE shall repay the amount of the excess to CITY.
- J. <u>Indemnification</u>. GRANTEE shall hold harmless, defend, and indemnify CITY, and its officers, agents, and employees against all claims, demands, actions, and suits (including all costs) brought against any of them arising from actions or omissions of GRANTEE and its officers, employees, agents, and contractors in the performance of this Agreement.
- K. <u>Insurance</u>. GRANTEE shall obtain and maintain in full force at its expense, throughout the duration of the Agreement and any extension periods, the required insurance identified below. CITY reserves the right to require additional insurance coverage as required by statutory or legal changes to the maximum liability that may be imposed on Oregon cities during the term of this Agreement.
 - 1. <u>Workers' Compensation Insurance</u>. GRANTEE, its contractors and all employers working under this Agreement shall comply with ORS Chapter 656 and as it may be amended from time to time. Unless exempt under ORS Chapter 656, GRANTEE, its contractors and any employers working under this Agreement shall maintain coverage for all subject workers for the duration of this Agreement.

In the event worker's compensation insurance coverage is due to expire during the term of this Agreement for any employers working under this agreement, GRANTEE agrees to require timely renewal of that insurance, either as a carrier-insured employer or a self-insured employer as provided by Chapter 656 of the Oregon Revised Statutes, before its expiration, and GRANTEE agrees to provide the CITY such further certification of worker's compensation insurance as renewals of said insurance occur.

2. <u>Commercial General Liability Insurance</u>. GRANTEE shall maintain commercial general liability insurance that covers GRANTEE as a named insured, and the CITY and its officers, agents, and employees as additional insureds, for property damage, bodily injury, personal injury, and advertising injury arising from GRANTEE's work under this Grant Agreement. The insurance shall provide coverage for not less than \$2,000,000 per occurrence.

- 3. <u>Automobile Liability Insurance</u>. GRANTEE shall have automobile liability insurance with coverage of not less than \$1,000,000 each accident. The insurance shall include coverage for any auto or all owned, scheduled, hired and non-owned auto.
- 4. Additional Insured. The liability insurance coverages, except Workers' Compensation where applicable, shall be without prejudice to coverage otherwise existing, and shall name the City of Portland and its bureaus/divisions, officers, agents and employees as Additional Insureds, with respect to the GRANTEE's or its contractor's activities to be performed or services to be provided. Grantee shall provide proof of additional insured coverage in the form of an additional insured endorsement form or a policy coverage document acceptable to CITY. Coverage shall be primary and non-contributory with any other insurance and selfinsurance. Notwithstanding the naming of additional insureds, the insurance shall protect each additional insured in the same manner as though a separate policy had been issued to each, but nothing herein shall operate to increase the insurer's liability as set forth elsewhere in the policy beyond the amount or amounts for which the insurer would have been liable if only one person or interest had been named as insured.
- 5. <u>Continuous Coverage; Notice of Cancellation</u>. GRANTEE shall maintain continuous, uninterrupted coverage for the duration of the Agreement. There shall be no termination, cancelation, material change, potential exhaustion of aggregate limits, or non-renewal of coverage without thirty (30) days written notice from GRANTEE to CITY. If the insurance is canceled or terminated prior to termination of the Agreement, GRANTEE shall immediately notify CITY and provide a new policy with the same terms. Any failure to comply with this clause shall constitute a material breach of the Agreement and shall be grounds for immediate termination of this Agreement.
- 6. Certificate(s) of Insurance. GRANTEE shall provide proof of insurance through acceptable certificates of insurance and a CG 2026 additional insured endorsement form (or an equivalent blanket additional insured form) to CITY on or before execution of the Agreement and prior to any commencement of work or delivery of goods or services under the Agreement or initial payment of grant funds. All certificates must specify the parties who are endorsed on the policy as additional insureds (or loss payees). Insurance coverages required under this Agreement shall be obtained from insurance companies acceptable to CITY. GRANTEE shall pay for all deductibles and premium from its nongrant funds. CITY reserves the right to require, at any time, complete and certified copies of the required insurance policies evidencing the coverage required. In lieu of filing the certificate of insurance required herein, if GRANTEE is a public body, GRANTEE may furnish a declaration that GRANTEE is selfinsured for public liability and property damage for a minimum of the amounts set forth in the Oregon Tort Claims Act (ORS 30.260 to 30.300).

- L. <u>Grantee's Contractor; Non-Assignment</u>. If GRANTEE utilizes contractors to complete its work under this Agreement, in whole or in part, GRANTEE shall require any of its contractors to agree, as to the portion contracted, to fulfill all obligations of the Agreement as specified in this Agreement. However, GRANTEE shall remain obligated for full performance hereunder, and CITY shall incur no obligation other than its obligations to GRANTEE hereunder. This Agreement shall not be assigned or transferred in whole or in part or any right or obligation hereunder, without prior written approval of CITY.
- M. <u>Independent Contractor Status</u>. GRANTEE, and its contractors and employees are not employees of CITY and are not eligible for any benefits through CITY, including without limitation, federal social security, health benefits, workers' compensation, unemployment compensation, and retirement benefits. GRANTEE will be responsible for any federal, state, or local taxes and fees applicable to payments hereunder.
- N. <u>Conflict of Interest</u>. No CITY officer or employee, during his or her tenure or for two (2) years thereafter, shall have any interest, direct or indirect, in Grant Agreement or the proceeds thereof. CITY officer or employee who selected GRANTEE, participated in the award of this Agreement or managed this Agreement shall not seek the promise of employment from GRANTEE or be employed by GRANTEE during the term of the Agreement, unless waiver is obtained from CITY in writing.
- O. <u>Oregon Laws and Forum</u>. This Agreement shall be construed according to the laws of the State of Oregon without regard to its provisions regarding conflicts of law. Any litigation between CITY and GRANTEE arising under this Agreement or out of work performed under this Agreement shall occur in Multnomah County court having jurisdiction thereof, and if in the federal courts, in the United States District Court for the State of Oregon.
- P. <u>Compliance with Law</u>. GRANTEE and all persons performing work under this Agreement shall comply with all applicable federal, state, and local laws and regulations, including reporting to and payment of all applicable federal, state and local taxes and filing of business license. If GRANTEE is a 501(c)(3) organization, GRANTEE shall maintain its nonprofit and taxexempt status during this Agreement. GRANTEE shall be Equal Employment Opportunity (EEO) and Equal Benefits (EB) certified by CITY to be eligible to receive grant funds.
- Q. <u>Independent Financial Audits/Reviews</u>. Any grantee receiving \$300,000 or more in City funding, in any program year, is required to obtain an independent audit of the City-funded program(s). Any grantee receiving between \$25,000 and \$300,000 in City funds, in any program year, is required to obtain an independent financial review. One copy of all required financial audits or reviews shall be submitted to the Grant Manager within thirty days of audit completion or upon request by the Grant Manager.
- R. <u>Severability</u>. CITY and GRANTEE agree that if any term or provision of this Agreement is declared by a court of competent jurisdiction to be illegal or in conflict with any law, the validity of the remaining terms and provisions shall not be affected, and the rights and obligations of the

Parties shall be construed and enforced as if the Agreement did not contain the particular term or provision held to be invalid.

- S. <u>Merger</u>. This Agreement contains the entire agreement between CITY and GRANTEE and supersedes all prior written or oral discussions or agreements. There are no oral or written understandings that vary or supplement the conditions of this Agreement that are not contained herein.
- T. <u>Program and Fiscal Monitoring</u>. CITY shall monitor on an as-needed basis to assure Agreement compliance. SCOPE OF WORK:

Describe briefly the Project/Program:

Constructing Hope (CH) will move 50 unemployed and underemployed Oregonians into careers with middle-class wages in the skilled construction trades. We will provide freeof-charge, 10-week construction skills and life skills training classes, expungement assistance, driver's license assistance, quarterly mentorship and hiring events, and case management, career placement services, tools, boots, and equipment for every participant. CH will implement a case management support specialist to lead expungement and driver's license services.

List the activities to be completed Fiscal Year 2019-20:

(1) Training, Placement, and Career Advancement Services

CH will deliver three 10-week, free-of-charge construction and life skills preapprenticeship training classes. Classes provide foundational training in the skilled construction trades, applied math, life skills, blueprint reading, and safety led by professional craftspeople. Classes, tutoring, and testing are followed by actual construction projects, while site visits offer insight into construction culture. Participants explore eight careers: Carpentry, Cement Masonry, Electrical, Ironwork, Laborer, Pipefitter/Steamfitter, Sheet Metal, and Heavy Equipment Operator.

Participants develop a trades résumé, plan for success, computer and job search skills, and job interview experience. Students learn personal accountability, financial planning, and effective communications. We provide construction (applied) math tutoring onsite.

CH will provide case management, transportation support, driver's license assistance, tools, work boots, and personal protective equipment. All participants earn certifications for First Aid/CPR; OSHA 40-hour HAZWOPER hazardous waste; NIEHS Toxic Use reduction; Forklift and Scissor Lift; Flagging; Confined Space; and OSHA-10 safety. In the first week of employment, we bring construction temporary employment industries to the classroom to provide "survival jobs" for students needing immediate employment while they are in the program. Graduates are placed in paid construction apprenticeships, pathway jobs leading to apprenticeship, and other career paths. Mentorship programs build connections for graduates with successful tradespeople of color. CH makes a three-year commitment to each graduate for placement, retention, and advancement services. CH will work directly with employers and apprenticeship centers to secure employment opportunities. We will also host or lead at least two events to connect graduates with contractors and apprenticeships.

(2) Expungement and Driver's License

CH will additionally deliver expungement services. CH will hire a part-time case management support specialist to handle expungement, driver's license assistance, and

database input and reporting. At intake, CH conducts a needs assessment and interviews each participant to learn about their legal history. The specialist will then guide clients in securing their DMV and criminal conviction history. He/she will then help them complete their materials, expungement information form, and letters needed for expungement and facilitate the connection to Metropolitan Public Defender (or similar agency in other jurisdictions). For participants requiring community service hours, CH is certified to provide up to 300 hours through our construction training program. The specialist will track and certify community service, developing additional assignments as needed. Driver's license support will include working with the client for a first license or renewal (including payment for lessons when needed) and with the public defender's office and DMV for driver's license restoration.

The specialist will help clients secure expungement and driver's licenses within the 10week class period with continued work as needed after the class period. CH currently assists with driver's licenses, and we refer clients to Rosewood Initiative for expungement. However, our staff do not currently have capacity to secure licenses within the 10-week class period, while Rosewood has limited slots and a huge backlog.

The specialist will perform data entry and reporting for Oregon I-Trac workforce database and CH's Apricot case management database, providing critical support for our case manager so that he can focus on client engagement and external relationship building for client supports.

Expungement services were piloted with assistance from a consultant in 2018. The consultant worked with Nikki Thompson at Metropolitan Public Defender. This grant will provide capacity to implement the project.

List the Strategies for Recruiting Participants:

This project will serve both CH students and graduates. Typically, at least 40% of program participants have a felony record. This project will allow us to complete or initiate services for any participant during the 10-week class.

Students are recruited year-round with 30-40 presentations including job fairs, community events, nonprofits, historically-black churches, parole officers, prison officials, WorkSource staff, and free, hands-on workshops. Outreach and clientele are predominantly located in the east side of Portland and in East Multnomah, with a focus on historical and emerging centers for African American residents. Recruitment will be led by diverse group of recruiters, including people of color.

For graduates, this project will serve clients who are working in construction but face employment barriers due to criminal justice history. For example, a recent graduate, "Charles," worked two weeks as an ironworker immediately after graduation. However, the ironworker's union is currently working on assignments for Intel, Nike, and other entities that do not allow employment of individuals with a felony history. Charles is currently working for a construction temporary agency at greatly reduced pay. With expungement services, we can often reduce felonies to misdemeanors. This would put Charles back to work.

CH makes a three-year commitment to graduates for case management and careeradvancement services. For graduates, recruitment will be conducted by the case manager as they follow up with students and at the mentoring events supported by this grant.

List clear and simple goals that will help define project/program success:

Success will be defined through the following goals:

- Outreach: 700 disadvantaged individuals learn about construction career opportunities.
- Enrollment: 70 participants receive individual screening and interviews and enroll in the training program.
- Completion: 55 participants graduate and are work ready.
- Placement: 40 graduates placed in construction careers, pathway jobs leading to construction, and other employment with average starting wage of \$18.50.
- Expungement (either completed or initiated during grant period): 30-40
- Driver's License (application or restoration): 18-30
- Mentorship events: 3
- Career Development: 50 current or former graduates benefit from job training through mentorship in support of career placement/advancement.
- Knowledge and experience: 100% of graduates demonstrate improvement in knowledge of career pathways, job search skills, construction skills, confidence, and understanding of construction culture and workplace expectations.

The eight month period represents three of CH's annual four construction training classes.

Describe how will you evaluate project/program:

To evaluate progress, we will collect data with respect to graduate placements in apprentice, pathway, and non-construction jobs, wages earned by graduates, number of expungements initiated and completed, number of driver's licenses secured, and graduates' learning with respect to career pathways and construction and job search skills. We will also collect data on demographics for our program, including participants' gender, ethnicity, criminal justice history, and income level. Data is stored in our Apricot case management database.

1. Operations Manager: Manage project, manage all staff including case management support specialist, manage contract billing and reporting. \$58,240 annual salary, allocated 36% for 8 months.

2. Executive Director: Supervise project. \$64,480 annual salary, allocated 3% for 8 months.

3. Classroom Program Coordinator: Lead teacher and manager for training program. Supervise contract instructors. \$48,880 annual salary, allocated 15% for 8 months.

4. Case Manager: Participants assessments; wrap-around service support; direct supports including tools and boots, union dues, bus tickets, childcare, etc.; and ongoing participant support. \$47,840 annual salary, allocated 15% for 8 months.

Job Developer: Connect graduates with apprenticeship centers, contractors, and other employers. \$47,840 annual salary, allocated 6% for 8 months. Will hire a new job developer this fiscal year. The classroom program coordinator is filling this position interim.
 Outreach Coordinator: Provide culturally specific and culturally responsive outreach. \$37,440 annual salary, allocated 3% for 8 months.

(B) Hourly Personnel

1. Case Management Support Specialist: Expungement, drivers license, community service hours management, case management data entry and records maintenance. \$21/hr, half-time, allocated 100% for 8 months.

(C) Contractors

Assistant Trade Instuctors: 2 instructors, 15 hrs/wk, 9 wks/class, 3 classes, \$25/hr for hands-on activities with 17% allocation. Trades and Math Instructors: 3 instructors, 15 hrs/wk, 9 wks/class, 3 classes, \$65/hr for hands-on activities with 33% allocation.

(D) Direct Program Expenses

Mentor Stipends: \$25 gas cards, 4 mentors, 3 events. Allocated 100%.

Classroom Supplies: Construction materials, supplies, and small tools. \$15,000 allocated at 7%.

Student Certifications: Flagging certification \$160/person, 70 persons, allocated at 36%. Matched with in-kind training and certifications from University of Washington: HAZ-WOPER, OSHA-10, First Aid/CPR and Confined Space: \$348/person=\$24,360. Student supports: Court fees, tools, personal protective equipment, work clothes, driver's license fees and driving lessons, union dues and initiation feeds. \$7,580 allocated at 22%

Graduation Expense: Food, speaker. \$2,500 allocated at 41%.
