### **Cannabis Social Equity Grants**

The Cannabis Social Equity Grant program is a tool for restorative justice, community reinvestment, and wealth creation in communities that have been most impacted by cannabis prohibition.



### **Program aligns with the City of Portland Comprehensive Plan:**

### Program also aligns with:

### Year 1



Portland Ballot Measure 26-180 established a 3% local tax on sale of recreational cannabis to be used for:

- Drug and alcohol education and treatment
- Public safety investments
- Support for small businesses, especially womenowned and minority-owned businesses... and economic opportunity and education to communities disproportionately impacted by cannabis prohibition



### **Cannabis Social Equity Grant** Review of Year 1

- Community survey to identify priority areas for • reinvestment of cannabis tax revenue
- Cannabis Tax Steering Committee recommendations





### Year 1 Priority Funding Areas:

#### \$350,000 – Office of Management & FinanceMF's Grants Office:

- Expungement and record-clearing
- Workforce development

#### \$150,000 - Prosper Portland:

• Small business development and technical support (NuLeaf)



# Selection process for \$350k managed by OMF Grants Office:

- Nine (9) applications received
- Selection committee recommended three projects for funding
- Recommended projects were approved by Council in August 2018



### Year 1 Projects Funded by \$350k

- Metropolitan Public Defender Services: Community Coalition Record Clearing Clinics
  - \$154,845
- Green Hop: Green Hop Academy
  - \$95,155
- Portland Opportunities Industrialization Center + Rosemary Anderson High School: Construction Pre-Apprenticeship Program
  - \$100,000





### Year 1 Outcomes to-date\*

- All projects are on track to meet outcomes ID's in grants
- More than 800 Portlanders have received services from programs funded by the Cannabis Social Equity Grant

### Cannabis Social Equity Grants: Year 2



### Proposed funding for Year 2 of Cannabis Social Equity Grants:

- Received 32 apps. (\$3.8 million) 3x more than Year 1
- Proposing to fund six (6) projects / programs at \$631,321
- Reinvestment in communities most harmed by cannabis prohibition





### **Cannabis Social Equity Grants: Year 2**

- Grants now administered by Civic Life's Cannabis Program
- One additional priority funding area
- Community listening session to shape application



### Year 2 priority funding areas

#### \$490,000 for:

- Expungement and record-clearing
- Workforce development
- Re-entry housing

#### \$210,000 to Prosper Portland for:

• Small business development and technical support (NuLeaf)



### **Selection process**

- 32 applications received
- \$3.8 million in need
- Review panel recommended six projects for funding
- Panel donated >230 hours of time
- All Year 1 projects were recommended for Year 2 funding



### **Proposing Year 2 Grants:**

- Requesting approval to fund these six (6) projects / programs at \$631,321
- Retroactive start date of October 1, 2019



### **Proposing Year 2 Grants:**

- Review Panel recommended the City utilize \$141,321 of currently available FY 19-20 cycle funds to fund the top six (6) applications
- Leaves \$758,679 for FY 19/20 cycle



# Projects proposed for continued Year 2 funding

- Portland Opportunities Industrialization Center + Rosemary Anderson High School: Construction Pre-Apprenticeship Program (\$100,000)
- Metropolitan Public Defender Services: Community Coalition Record Clearing Clinics (\$150,000)
- **Green Hop:** Green Hop Academy (\$150,000)



### New proposed projects for Year 2

- **SE Works:** YouthWorks (\$71,321)
- **Voz:** Building Economic Power for Day Laborers (\$60,000)
- **Constructing Hope:** Building Equity (\$100,000)



### One Year 2 applicant requested a scope modification:

- Increase pay rate for participants
- Increase 26-week apprenticeships from 5 to 7 total
- Reduce 10-week internships from 20 to 10 total
- No change to overall requested amount



### What we've learned, how we've adapted, what we still need to do:

- Increase support for applicants
- Continue to improve our grantmaking process
- Seek out strategic opportunities to make upstream changes and investments
- Deepen community relationships and engagement
