Purpose of proposed legislation and background information:

The Bureau of Environmental Services (BES) protects public health, water quality and the environment. It provides sewer and stormwater collection and treatment services to accommodate Portland's current and future needs. BES protects the quality of surface and ground water and conducts activities that protect and restore our watersheds. The services provided by BES are paid by our ratepayers through user fees approved annually by Council.

In August 2016, via Ordinance No. 187926, City Council authorized changes to PCC 17.36 to more clearly allow the BES Bureau Director to authorize reimbursement payments to customers for billing errors. Assuming certain conditions are met, the Bureau Director is authorized to reimburse for up to three years of billing errors. Requests for reimbursement beyond that period may be put forth to City Council for authorization. The currently proposed Ordinance is the first such action to come before City Council under the revised code authority.

Renee C. Holmes has been charged for, and has paid, sewer user charges for the property located at 7326 N. Williams Avenue since August 29, 2002. Sewer user charges were calculated based on actual water volume or a winter average, whichever was less. A winter average is the amount of water volume measured in the winter months.

In January of 2017, BES was notified by the property owner that the property is not, and has not been, connected to the City sewer system. BES has confirmed that Renee C. Holmes was the property owner, the property was not connected to the sewer system, and charges were billed and collected in error. Under the authority of City Code section 17.36.090 A, BES has provided Renee C. Holmes a credit for the most recent three years of user charges billed in error, from the date the error was discovered. However, PCC 17.36.090 A does not allow the Bureau to grant adjustments, waive fees, or pay refunds prior to the most recent three years.

This ordinance facilitates fair and equitable BES sewer billing by ensuring the ratepayer, Renee C. Holmes, is not charged for services the City has not provided for the property located at 7326 N. Williams Avenue. This ordinance authorizes the Bureau to estimate sewer volume charges which were billed to and paid by Renee C. Holmes in error between August 29, 2002 and September 9, 2013 and to refund those charges to the ratepayer.

The ordinance is requested on an emergency basis so that funds that were charged and collected in error can be provided to the ratepayer in a timely manner.

Financial and budgetary impacts:

No budget changes or additional costs are expected to result from this Ordinance.

Community impacts and community involvement:

The proposed ordinance will benefit BES ratepayers by ensuring equitable, accurate and appropriate sewer user billing.
