Thence, leaving said West line, North 45°57'56" East, a distance of 78.96 feet, to the Northeasterly line of said tract, also being the Southwesterly Right of Way line of S.W. Garden Home Road;

Thence, along said Right of Way line, South 44°02'02" East, a distance of 10.00 feet to the POINT OF BEGINNING.

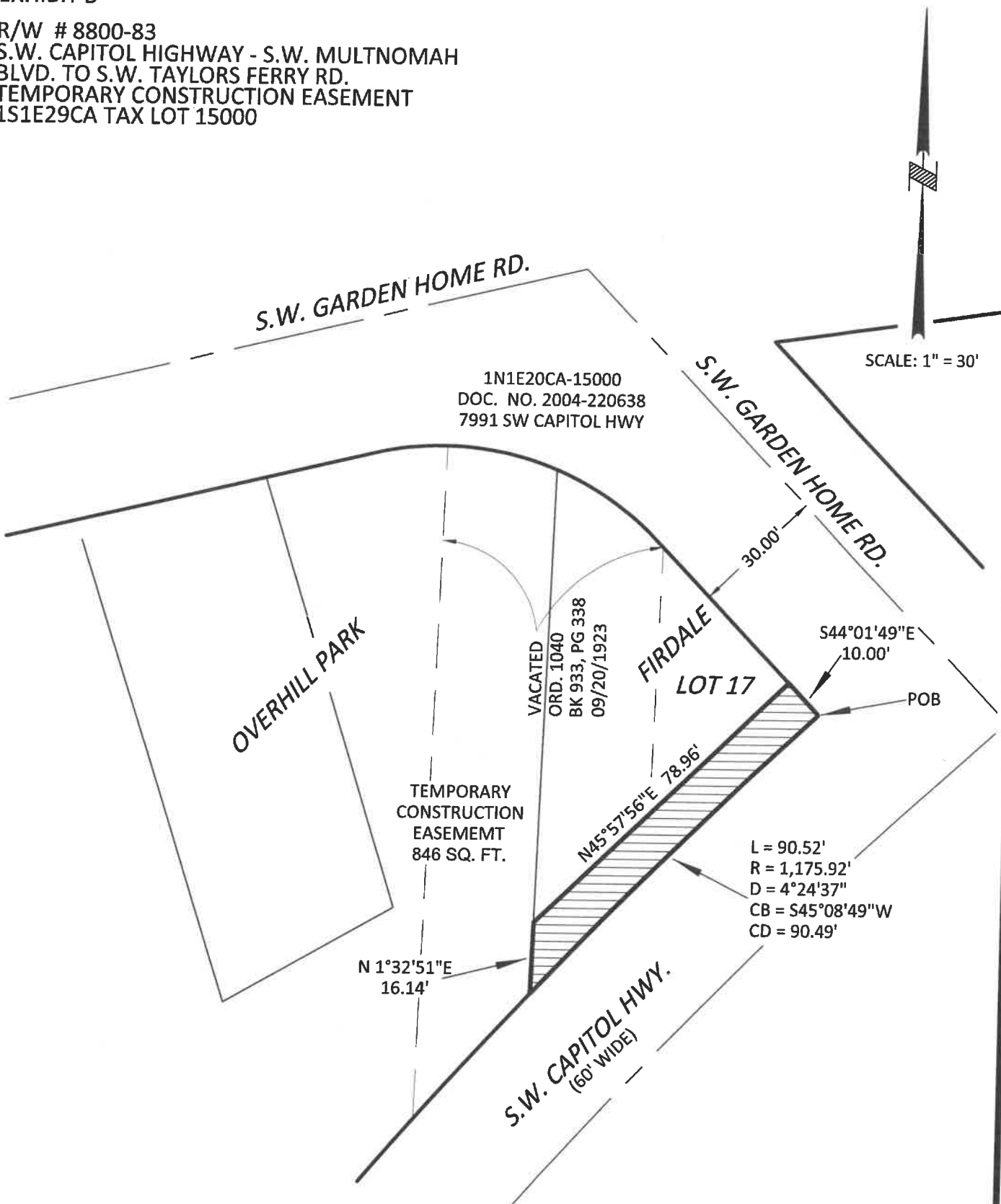

Thence, North 61°16'48" West, a distance of 1.87 feet, to said East Right of Way line, also being a point of non-tangent circular curve;

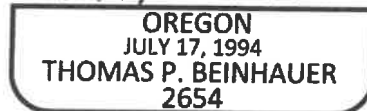
