

Resolution Goals

By 2035

- 100 percent renewable electricity.
- 2 percent community-based development.

By 2050

- 100 percent renewable transportation and heating.
- 10 percent community-based development.





What 100% Renewables Means

- Reduce use of all fossil fuels in buildings and reduce need for vehicle trips.
- Generate 100 percent renewable electricity.
- Use renewable transportation fuels for all remaining vehicle trips.
- Replace fossil fuels used to heat buildings with renewable heating fuels.


