Upcoming Council Items

- Regular, emergency ordinance amending the Housing Development Center contract for the Bureau of Planning and Sustainability to commission a feasibility report for affordable housing in the SW Corridor (Jill Chen) *March 28, 2018*
- NE Housing Strategy Annual Report (Leslie Goodlow) *Time Certain Confirmed for 10:00 am April 4, 2018*
- Framework HIPP staff is currently underwriting the Framework project. Need to move City Council to April 4, 2018.

General Updates

- Permanent Mandatory Renter Relocation Assistance adopted on emergency on March 7. Since March 9 staff have responded to approximately 130 queries from either phone calls, emails or walk-ins. Have received approximately 40 exemption applications. Already receiving notices of payments made which is not mandated until May 1.
- Ordinance to "incent the pipeline" for pre-Inclusionary Housing projects was passed by City Council and is going to the Board of County Commissioners.
- BPS: Residential Infill Project (RIP) Proposes an affordable housing bonus for single-dwelling zones. Proposed Draft due out beginning of April.
- BPS: Better Housing by Design (BHD) Proposes four affordable housing bonuses; two new and two reconfigured options. Public comment period on the Discussion Draft closed on March 19.
- PBOT: Transportation Demand Management (TDM) Plans Amends administrative rules to require a multi-modal financial incentive in new developments of 10 or more dwelling units. Draft of the administrative rules due out beginning of April.
- City/County Joint Office of Homeless Services IGA (Inter Governmental Agreement). The City invests significant resources in programs and community initiatives to prevent and end homelessness for thousands of households each year. The budget for homeless services is passed to, and directly administered by, the City/County Joint Office of Homeless Services (JOHS). Funding consists of City General Funds and federal Emergency Solutions Grant (ESG)

and Housing Opportunities for Persons with AIDS (HOPWA) grant funds from the U.S. Department of Housing and Urban Development (HUD).

The JOHS was formed by an IGA established between the City and Multnomah County in July 2016. The IGA authorizes JOHS with the primary functions of:

- Leading policy, planning, coordination efforts and centralized funding for homeless services in Multhomah County; including staffing and advancing policies and priorities of the <u>A Home for Everyone</u> communitywide collaboration;
- Administering subrecipient contracts to more than 21 nonprofit and public agencies, to provide a comprehensive range of services to assist people experiencing homelessness or housing instability. Primary service categories are:
 - Supportive Housing (in collaboration with PHB related to city-regulated affordable housing)
 - Diversion and Employment
 - Housing Placement & Retention
 - Safety off the Streets (including emergency shelter operations)
 - System Support Services
- Tracking quarterly and annual performance measures in HMIS (Homeless Management Information System) for A Home for Everyone initiatives and other associated homeless service investments;
- Conducting and publishing the annual/bi-annual Point-In-Time Count of Homelessness for Portland/Gresham/Multnomah County. The JOHS reports to the Policy & Budget Alignment Committee (PBAC), comprised of elected and appointed officials from the City and County.
