Re: Appoint Joy Mulumba to be Available to Serve on the Police Review Board

In 2010, Portland City Council amended City Code 3.20 which governs the processes and structure of Portland Police Bureau's performance and use of force review boards. As part of the changes approved by Council, the Police Bureau will select citizen members for the Police Review Board from a pool of volunteers recommended by the City Auditor and appointed by City Council.

My recommendation for appointment is Joy Mulumba. His biography is listed below. Mr. Mulumba was recommended by a selection committee consisting of staff from the Auditor's Independent Police Review, two members of the Citizen Review Committee, a community member and a sworn member of the Police Bureau. If confirmed by Council, his term begins February 12, 2020 and will end February 10, 2023. The appointment of Joy Mulumba will bring the total number of community member volunteers to fifteen.

Mr. Joy Mulumba received his Master of Arts degree in English from Portland State University. He has worked as a nurse assistant in different departments at OHSU and Providence Hospitals for 8 years. He currently serves the African immigrants and refugees' families through a non-profit and works at the library. When he is not reading, writing or spending time with family, he can be found on the mats learning the gentle art of Brazilian Jiu-Jitsu.
