Julia Delgado

Julia's career has been especially focused on racial equity, with the last 15 years working on the intersection of racial equity and housing. From working on the racial equity strategy guide that the city has adopted to oversight of supportive housing for eight years, Julia's work has been community focused. She continually works to explore opposing viewpoints and accept new information to refine their own perspective. Throughout their time of service on PHAC Julia is committed to focusing on bringing practices, policies, and investments in housing to be focused on justice and restoration of decades of racial exclusion and harm. Julia is excited to participate on the Portland Housing Advisory Commission to have an impact on the housing crisis that most greatly impacts BIPOC in the city and to improve quality of life in the city they love.

Dike has been at the forefront of real estate financing and development for more than forty years. As a developer, Dike plans, organizes, leads and controls his company's activities. He has been responsible for negotiating complex development agreements with multiple public entities and formulating multifaceted financial structures.
