An Ordinance vacating all that portion of Twentieth Street lying between a line 100 feet southerly from and parallel with the southerly line of Spring Street and the northwesterly side line of Elizabeth Street, save and except a strip of land ten feet in width, being five feet on each side of the center line of Twentieth Street lying between the lines as above described.

WHEREAS, due and legal notice was given by advertisement thereof for four consecutive weeks, to-wit: from Saturday October 21st, 1905, to Saturday, November 25th, 1905, both days inclusive, in the city official newspaper of the City of Portland, Oregon, to-wit: the Portland Daily Abstract, published in said city, that at a regular meeting of the Council of said City to be held on Wednesday, the 5th day of December, 1905, a petition would be presented to said Council praying for the vacation of all that portion of Twentieth Street lying between a line 100 feet southerly from and parallel with the southerly line of Spring Street and the north-westerly side line of Elizabeth Street, save and except a strip of land ten feet in width, being five feet on each side of the center line of Twentieth Street, lying between the lines as above described, in said City, which said notice with the proof of the publication thereof was. filed in the office of the Auditor of said City on said 6th day of December, 1905, and

WHEREAS, said petition was duly presented to the Council on said day in said notice, which petition duly set forth a description of the portion of Twentieth Street sought to be vacated, and the reason therefore; and

WHEREAS, there was filed in the office of the Auditor with said petition, and as a basis for such vacation and for granting of the prayer of said petition, the consent of the owners in fee simple of over two-thirds of the real property fronting on both sides of that portion of said street sought to be vacated, as well as the extension of said frontage, in accordance with Section 362 of the Charter of the City of Portland, which consent was duly acknowledged by the owners of the property so fronting upon the said street sought to be vacated; and

WHEREAS, the Council upon the presentation of said petition and the filing of the proof of publication of said notice, did fix the regular meeting of the Council on Wednesday the 20th day of December, 1905, at the regular meeting place at Portland, Oregon, as the time for hearing said petition, and objections thereto, and

WHEREAS, said Council has ascertained and determined, and does hereby ascertain and determined, and cause to be made a matter of record, that all of the hereinbefore recited acts and things have been done, and that the consent of the owners of the requisite number of front feet has been duly obtained and that the public interests would not be prejudiced by the vacation of that portion of Twentieth Street aforesaid; and

WHEREAS, no objections have been filed to said petition, or to the vacation of Twentieth Street, as therein prayed,

The City of Portland does ordain as follows:

Section 1: That all that portion of Twentieth Street lying between a line 100 feet southerly from and parallel with the southerly line of Spring Street and the northwesterly side line of Elizabeth Street, save and except a strip of land ten feet in width, being five feet on each side of the center line of Twentieth Street lying between the lines as above described, in said City, be and the same is hereby vacated.

The foregoing ordinance was submitted to the Mayor January 4th, 1906, and not being approved by him, or returned with his reasons for not approving it within ten days thereafter, has therefore become a law as if he had approved it as provided by Section 50 of the Charter.
