

## Ordinance No. 74334

An Ordinance accepting certain property for the opening of Northeast Davis Street, in the City of Portland, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. That the following described deed be and is hereby accepted by the City of Portland for street purposes:

Beginning at a point on the west line of Northeast 28th Avenue, 220 feet north along said west line of Northeast 28th Avenue from the point of its intersection with the north line of Northeast Couch Street for a true point of beginning; running thence west and parallel to the north line of Northeast Couch Street 330 feet, more or less, to the east line of Etna, an addition to the City of Portland; thence north upon said east line of Etna, an addition to the City of Portland, 10 feet to a point; thence east and parallel to the north line of Northeast Couch Street 100 feet to a point; thence north and parallel to the west line of Northeast 28th Avenue 13 feet, more or less, to the south line of the 7.6 acre tract of land heretofore owned by one Creighton; thence east along the south line of said Creighton tract 230 feet, more or less, to the west line of Northeast 28th Avenue; thence south along the west line of Northeast 28th Avenue 23 feet, more or less, to the place of beginning. (Deeded by School District No. 1)

Section 2. That the City Auditor be and he is hereby directed to have the deed for street purposes as described in section 1 of this ordinance placed on record and a copy of said ordinance forwarded to the County Assessor.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: It is necessary that this street be opened as a public thoroughfare at the earliest possible date; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
