ORDINANCE No. 90478

An Ordinance authorizing the Mayor and Auditor to draw a warrant on the General Fund in favor of I. A. Hagen, president of Lagen Construction Company, 5650 N. E. Wygant Street, covering refund on building permit fee, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. The Council finds that building permit No. 297810 was issued to Hagen Construction Company by I. A. Hagen, president, 5650 N. E. Wygant Street, on may 14, 1948, for construction of a house at 3420 N. E. Academy Avenue, for which a fee of \$10.50 was received. I. A. Hagen, 5650 N. E. Wygant Street, did not construct the dwelling authorized under said permit, but sold the lot on which the dwelling was to be erected and is now asking for a refund of \$10.50 fee paid for building permit No. 297810, that payment of this fee is evidenced by City Treasurer's receipt No. 37361, and a refund is approved by the Commissioner of Finance; now, therefore, the mayor and Auditor be and they are hereby authorized to draw a warrant in favor of I. A. Lagen, 5650 N. E. Wygant, in the amount of \$10.50 less \$2.50 service charge making a total of #8.00, which warrant shall be made chargeable to the General Fund appropriation Refund 4700.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: that no undue delay should be occasioned in the settlement of refunds such as the above; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
