## ORDINANCE No. 91025

An Ordinance designating and assigning as street area Lot 1 and a portion of Lot 2 in Block 13, Peninsular Addition, now owned by the City of Portland, and declaring an emergency.

The City of Portland has ordained as follows:

Section 1. It appearing to the Council that certain property, as hereinafter described, has been acquired by the City of Portland (Sewage Disposal Fund); that the parcel of land herein described is required for the widening of N. Delaware Avenue and such will not be a detriment to the Sewage Disposal System and will contribute to the public convenience in the use of said property by providing better street access; now, therefore, the following described parcels of property are hereby designated and assigned to the use aforesaid. Said parcels of property to be used for the purposes herein mentioned are more particularly described as follows:

Lot 1, Block 13, Peninsular Addition; also all of that portion of Lot 2 in Block 13, Peninsular Addition south and west of a straight line extending from the northwest corner of said Lot 2 southeasterly to the southeast corner of said Lot 2.

Section 2. That the City Auditor be and he is hereby directed to have a certified copy of this ordinance placed on record and a copy of said ordinance forwarded to the County Assessor.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: The use of said property for street purposes is needed without delay; therefore, an emergency is hereby declared to exist and this ordinance shallbe in force and effect from and after its passage by the Council.
