ORDINANCE NO. 114159

An Ordinance authorizing and directing Blanche Durst, Tabulating Equipment Supervisor in the Office of the City Auditor, to attend the Annual Meeting of the Western Division, National Machine Accountants Association to be held in Long Beach, California, October 25, 26 and 27, 1961, granting a leave of absence with pay, authorizing the drawing of a warrant for \$250, providing for an accounting, and declaring an emergency.

The City of Portland does ordain as follows:

The Council finds that the Annual Meeting of the Western Division, National Machine Accountants Association is to be held in Long Beach, California, October 25, 26 and 27, 1961; that it is desireable to have Blanche Durst, Tabulating Equipment Supervisor in the Office of the City Auditor, attend this meeting in order to gain information concerning machine accounting problems which will be of value to the City of Portland; that Blanche Durst is a member of the board of the local chapter of said association which will make a bid for bringing the 1962 convention to Portland and that it would be in the best interest of the City of Portland to send Blanche Durst to said meeting; now, therefore, Blanche Durst, Tabulating Equipment Supervisor in the Office of the City Auditor, is hereby authorized and directed to attend the Annual Meeting of the Western Division, National Machine Accountants Association in Long Beach, California, October 25, 26 and 27, 1961, and leave of absence with pay is hereby granted together with necessary travel time.

Section 2. The Mayor and the Auditor are hereby authorized to draw a warrant for \$250 in favor of Blanche Durst, chargeable to the General Fund appropriation Travel and Employee Education, Code No. 5035. It is hereby specifically provided that Blanche Durst shall file with the Auditor a statement together with such vouchers as are obtainable showing cost of hotels, transportation, meals, etc., and any remaining balance shall be returned to the General Fund and placed to the credit of the appropriation on which the warrant was drawn.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that Blanche Durst may make arrangements for the trip authorized in Section 1. above; therefore, an emergency is hereby declared to exist, and this
