1. Auditorium site

Boundaries: S.W. Market St. to S.W. Hall St. from 3rd Ave. to Front Ave.
 Legal Description: Blocks 117, 118, 119, 120, 123, 124, 125, 126, 133
 134, 135 and 136; Portland addition

2. Power House Site

Boundaries: Southern Pacific Co. tracks on the west to Willamette River
 on the East; Ross Island Bridge on the South to extension of Lincoln
 St. (N. line of tax lot 15) on the north.
 Legal Description; tax lots 1, 12 (City of Portland), 15, 38, 40 and 41
 Caruthers Assition

3. Journal Site

Boundaries: Between S.W. 2nd Ave and Front Ave and between Madison and
 Morrison Streets.
 -Any 4 adjoining blocks of the 10 -

4. Ross Island Site

Boundaries: Ross Island, Hardtack Island and Oaks Park area

Boundaries: Sput track on north, S.P. & S. Railroad on west, Columbia
 Slough on the south and N. Denver on the East.
 Legal Description; tax lot 5, 7, 9, 10, 11, 12 (625 acres), 13, 14, 15, 18 and
 S $\frac{1}{2}$ of tax lot 2; Section 4 1N 1E

7. East Vanport

Boundaries: N.E. Union Ave on the east to N. Vancouver Ave, to Columbia
 Slough on the south to Denver Ave on the northwest.
 Legal Description: tax lots 2, 3, 5, 15, 26, 33, 39, 42, 44, 45 (Delta Park 98.85 acres)
 49, 50, 65, 67, 74, 82, 90, 100, 102, 122, Section 4 1N 1E; tax lots 4 to

8. Morningside Hospital Site

Boundaries: S.E. 96th Ave on the West, S.E. Stark St. on the north,
 S.E. 110th Ave on the East and S.E. Market St. on the South.

9. Glendover Golf Course Site
Boundaries: N.E. Halsey St. on the north, N.E. 148th Ave on the east
N.E. Glisan St. on the South and N.E. 132nd Ave (approximately)
