Out of \$750,000 taken from the workers wages for the Community Chest only \$200,000 was set aside for so-called "relief". The balance goes for graft and maintaining anti-working-class organizations, the Y.M.C.A. the Y.W.C.A. etc.. Due to this fact we are faced with even less "relief" than we are now getting!

### "American Independence"

WORKERS; are we going to starve as they want us to without a protest? We must organize into Unemployed Councils to fight for more and better relief! # WORKERS' OF S.W. PORTLAND

Hundreds of us are having our relief work taken away from us, and the rest cut down to the lowest level since the beginning of the crisis; our welfare orders are being treated in the same manner in addition to uncalled for insults from the welfare agents; evictions are taking place; water, lights and gas are being shut off, adding more misery to the unemployed and their families. All this is being done through the bally-hoo that the Nat'l Industrial Recovery Act will immediately bring back that long lost prosperity; all this is being done because the workers have been propagandized into a stage of passivity believing that they will surely get a job in a few days, therefore failing to see the necessity of organizing and struggling, not only to keep the relief they had, but to get more. Wage cuts are becoming a greater weapon of the bosses to unload on the backs of the workers the entire burden of the present crisis, to maintain the already swollen profits of the rich. Every such cut is a blow to the entire working class, one only leading to more. If either of the above cuts take place through "arbitration" where will they fall next and how long before the knife again reaches YOU. THE TIME TO STOP WAGE CUTS IS NOW!!

In many parts of the country, rank and file workers (Carpenters in Boston) have gone over the heads of their officials, who tried to give them a sugar-coated cut through "arbitration" and went on STRIKE! Many of them have won their struggles, they would not be sold out!

The Unemployed Council of Portland has voted unanimously to give its full support to any and all workers who determine to fight against wagecuts, officials or no officials.

We warn the Building Trades Workers that if the boss succeeds in this cut it will be a blow not only to themselves but to all other workers. With confidence the bosses will continue cutting to the bone.

Will you be creating "strained relations" by resisting this cut. NO! The boss has already done this, the rest is up to you.

BUILDING TRADES WORKERS! If you want to fight this cut, elect rank and file committees to represent you and present your demands to the boss. NO WAGE CUT! 6hr. day, 5 day week, with no reduction in pay! NO ARBITRATION! DON'T PUT YOUR FATE IN THE HANDS OF THE BOSS!

While wage cuts are increasing, the other side of the picture, unemployment, grows darker. Millions are without the barest necessities, hundreds right here in Portland. While fighting against wage cuts, hand in hand must go the fight for unemployment relief. Not to force the employed to support the unemployed but to force the rich to part with some of the ill gotten wealth.

February 4th. is a national day of struggle for unemployment insurance, to force Congress to pass the unemployment insurance bill presented by the National Hunger March. All workers organizations are urged to send delegates to a United Front Conference, to prepare for February 4th., to be held at Workers Hall, 191½ 3rd. St. Elect delegates and attend the United Front Conference.

## PROGRAM FOR IMMEDIATE UNEMPLOYMENT RELIEF

### UNEMPLOYED COUNCIL OF PORTLAND

Appropriation from the city budget of a fund of \$ 1,500,000 for immediate relief, of the unemployed workers' fund to be raised by the following means.

- (1) Reduction of salaries of city officials to a maximum of \$2,500 per year.
- (2) Reduction of city police force by one half, cancellation of funds for new equipment, enlargement of force, to be reverted to relief funds.
- (3) Censor board funds to be reverted to relief funds.
- (4) Special tax levy on property with valuation in excess of \$25,000
- (5) Interest, redemption, and sinking funds on city bonds to be reverted to this purpose.
- (6) All community funds to be turned over for this purpose.

### ADMINISTRATION OF RELIEF

Relief shall be administered by a city board of workers' elected from factory councils, rank and file members of trade unions, and unemployed councils.

Relief shall be provided for all unemployed workers in Portland regardless of race, color, creed, nationality, occupation, age, sex, or residential qualifications.

The city board of workers' shall constitute a free city employment bureau, all other private and government agencies shall be abolished

### IMMEDIATE DEMANDS FOR UNEMPLOYMENT RELIEF

- (1) No evictions of unemployed workers for non-payment of rent.
- (2) No Gas, light, or water, to be turned off in homes of unemployed workers
- (3) Free food and clothing to be furnished to children of unemployed workers by schools.
- (4) Free transportation on street cars and busses for unemployed workers and their dependents.
- (5) Vacant buildings and houses to be put at disposal of unemployed workers in such shape as to provide decent accommodations.
- (6) Free medical, dental, and hospital service for unemployed workers and their dependents.
- (7) Immediate abolition of all vagrancy, and other anti-labor laws.
- (8) Immediate abolition of the vicious criminal syndicalist laws.
- (9) Public hall and auditoriums to be free to workers for meeting purposes.
- (10) No police interference of workers, or unemployed meetings.
- (11) Union wages to be paid on city and public works.
- (12) Immediate institution of the 7hr. day and the 5 day week.
- (13) Community funds to be turned over and put at disposal of city board of workers for unemployment relief.
- (14) All unemployed workers to be exempt from taxation beginning 1930

All unemployed workers are asked to join the unemployed council to fight for the above demands, and support the National Unemployment Insurance Bill.
