

ORDINANCE NO. 148978

An Ordinance creating one position of Parks Development Supervisor (Job Class 4162) and abolishing one position of Administrative Assistant II (Job Class 0820) in the Bureau of Parks, Planning and Development Division; establishing rates for the Compensation Plan, and declaring an emergency.

Section 1. The Council finds:

1. One position of Parks Development Supervisor is required by the Bureau of Parks, Planning and Development Division.
2. The position currently classified as Administrative Assistant II in the Planning and Development Division was audited and the Civil Service Board determined new classification (Parks Development Supervisor, #4162) and rate of pay should be created for this position.
3. The Administrative Assistant II position should be abolished to provide partial appropriation for the position being created.
4. The necessary additional appropriation will be provided by transfer within the bureau.
5. The new salary rates have been approved by the Bureau of Personnel Services.

NOW, THEREFORE, the Council directs:


c. Hourly rates for the new position classification not in the current Compensation Plan are established as follows:
